4.1 Committee Mandate

4.2 Attendance Boundary Process

Mr. Ammendolia reviewed the framework of the Attendance Boundary Review (ABR) specifically:

- The roles of each of the participants through the process.
- The order in which things occur in the 10-month duration.

4.3 Drivers of Attendance Boundary Reviews

Mr. Ammendolia noted that boundary reviews are conducted to create a balance because of one or more of the following:

- Student enrolment.
- New school facilities.
- Program changes.

4.4 Why a Review?

Mr. Ammendolia highlighted that the high utilization in Brant, SW Brantford and Brantford need to be addressed. The Board has been granted funding for two new elementary schools to be built. Collectively reviewed, this can balance out the existing utilization concerns.

4.5 Intended Outcomes and Key Considerations

Mr. Ammendolia noted that some of the possible outcomes and key considerations may work on paper, but there will be many factors that need to be reviewed as well. Some of these items include transportation, walking distance to school, property size, portables, washrooms, and parking spots. These additional items will provide further insight into what is occurring at each of the facilities.

The Committee must assist in determining what can be done in the best interests of the students, school, and continuously growing community.

4.6 Current Situation and Student Distribution

Mr. Ammendolia reviewed current demographics regarding the schools' historical enrolments and utilizations. He briefly touched on current attendance boundaries and the anticipated residential growth in the areas. We are looking at finding a sustainable solution.

Presented slides that focused on the dramatic changes which have occurred in the population growth since 2011:

- Utilization Rates the enrolment of the school compared to what the school was built for (not including portables).
- Current student distribution in each of the school's catchment areas.

4.7 Attendance Boundaries

A visual map highlighted the school locations and their proximity to one another.

4.8 Next Steps

- There is a significant amount of time for this review.
- Development of options for consideration to be presented to the committee.
- Public Consultation Meeting to take place in late fall/early winter.
- Final options to be presented to the Trustees for approval in the spring.
