- Committee Members to provide final recommendation(s) to present to Trustees.




There are two primary questions for the committee to answer:

 Should students attending schools out of boundary be returned to their home school? Should some grades/students have legacy provisions and be allowed to remain at their existing schools?







- Concern for St. Mary's CES utilization remaining above 100%





- St. Patrick's CES would drop to 55% utilization.







Recommendations

- Does the committee agree with the public, regarding options 2 (i.e. schools outside Caledonia) and to not consider those options as part of the final recommendation?
- Option 1A or 1B?
 - Consultant Info: Option 1B has a greater number of existing students remaining at St. Patrick and more available space at Pope Francis upon opening, leaving more room for future enrolment growth.
- Enforce boundary crossing (return students to home schools)?
- Legacy Agreements? (analysis on next slide)

Legacy Agreements



- 1. Question Asked From the Public: Can all existing students have legacy provisions?
 - No. There would not be enough students to open the new school and ensure proper resources and staffing.
- 2. Options considered are to legacy students **currently**:
- a. In Grade 6 + siblings = 67 total students (Option 1a) OR 64 total students (Option 1b)
- b. In Grades 5 & 6 + siblings = 99 total students (Option 1a) OR 96 total students (Option 1b)
