#### 2. Committee and Staff Reports

### 2.1 Review of the Draft Multi-Year Integrated Accessibility Plan 2018-2023

Chair Shypula reviewed the drafted Multi-Year Integrated Accessibility Plan 2018-2023. Based on changes within the Plan on design of public spaces, updates will be made to the Accessibility Standards Policy 200.33 and Administrative Procedures for Integrated Accessibility Standards Regulations for Customer Service 200.34, Employment 200.35, Information and Communications 200.36 and Transportation 200.37 and posted to the Board website. Chair Shypula reviewed sections on *Information and Communications* and *Design of Public Spaces areas* and updated on our compliance to these standards from the Requirements of the Integrated Accessibility Regulation Chart found on page 3 of the Plan. Group discussions ensued on Outdoor Spaces and a review of the extensive criteria for ground materials. Section 8.0 for Barrier Identification, found on page 9 of the Plan was reviewed and the group considered all discussions on costs, Ontario Building Codes and students with special needs. The Information Technology Department continues to monitor and update our Website and Web content based on Web Content Accessibility Guidelines (WCAG).
