2. Welcome and Opening Comments

Jill Esposto, SEAC Chair, welcomed the group. Superintendent Shypula led a round of introductions for the benefit of new members.

Director of Education & Secretary, Chris Roehrig presented a Discussion Guide from the Ministry of Education on School Board Governance Supports. 5. Community Agency Updates

Jill Esposto- Director of Services- Brant Family & Children Services

Jill updated that there is a consultant currently working with a group of representatives from school boards and child welfare agencies on the Joint Protocol for Student Achievement (JPSA). This protocol is meant to work alongside other protocols currently in place between school boards and their local agencies regarding child abuse reporting. The purpose of JPSA is to support the educational success and wellbeing of children and youth involved in the child welfare system and to help them reach their

full potential. This supports the realization of the Renewed Vision for Education in Ontario. The following is a list of school boards and child welfare agencies participating:

Jill updated on how new and mandatory processes for hiring employees at BFACS fall into a 4 to 6 month timeframe. The agency is approximately half way through the implementation of the Child Protection Information Network (CPIN), a data collection and storage system that is being used by all Children's Aid agencies across the province. BFACS is slated to have full implementation on the program by May 2018.

Jill shared that Six Nations is transitioning to provide its own child welfare and Ogwadeni:Deo (OGD) is the agency that will be taking over the child welfare mandate for Six Nations. There is a transition process for the families and children that move over to the new agency once the Ministry announces the mandate has been designated to OGD. Additional details will be forthcoming early in 2018.

Additional information concerning the changes with the Child Youth and Family Service Act and how it will affect services for youth ages 16 & 17 will also be forthcoming in the new year.

Mischa Jansink- Family Service Coordinator- Lansdowne Children's Centre

Mischa updated that Lansdowne will be holding their Annual Christmas party on Sunday, December 3, 2017. Families in care have the choice between three different time slots.

Jennifer Chapman- Child Welfare Supervisor, Haldimand-Norfolk Children's Aid Society

Jennifer shared that the agency is currently preparing for their Christmas dinner and is accepting donations. A decrease in the number of children in care within the agency has resulted in a review of caseloads and demands.

Bonnie McKinnon- Trustee Representative, Brant Haldimand Norfolk Catholic District School Board

Bonnie shared that today was *Giving Tuesday*. Giving Tuesday is described as a global movement for giving and volunteering after Black Friday. It is about the generosity of people, organizations, etc. collaborating and giving back to their communities through acts of kindness.

Teresa Westergaard-Hager- Supervisor, Community Outreach, Norfolk Association for Community Living

Teresa updated on how Norfolk Association for Community Living is implementing changes within the recruitment department in an effort to decrease turn over within the agency. The agency has received enhanced emergency funding. There is a big focus on transitions with Children and Family services and addressing needs including mental health services.

Teresa attended a *Youth Wellness Hubs Ontario Community Partnership Collaboration* meeting and shared that the Ministry of Health and Long-Term Care announced funding support for integrated service hubs. The hubs will provide mental health and substance use services as well as other health, social and employment supports to youth between the ages of 12 and 25. The committee is currently developing a proposal.

6. Reports

6.1 Student Achievement Leader: Special Education

At the Community of Practice (COP) on Friday, November 24, 2017, Sara Pettigrew from the *Ministry of Community and Social Services* (MCSS)/Ministry of Children and Youth Services (MCYS) presented information about the 'Assistance for Children with Severe Disabilities' (ACSD) program. An overview of the application process including eligibility, the different programs (Special Services at Home, Medically Fragile and Technologically Dependent, etc.) was shared. In addition, to assist with connecting students with special needs to social assistance, Special Education Resource Teachers (SERTs) received information from Garth Graves, Joanne Milne and Christy White from the Brant Office of the Ministry of Community and Social Services on who is eligible to apply for the Ontario Disability Support Program (ODSP). SERTs received examples of the application packages as well as online information. Discussions ensued about eligibility to many services available from a home based view and from an educator's point of view. Members discussed the importance of connecting students with special needs to resources through Coordinated Service Planning. Carmen noted to SEAC members to contact her if they had suggestions or information that would be beneficial to present to SERTs at any of the upcoming COPs.

Kerri Chartrand, Student Achievement Leader – School Effectiveness, provided information on Number Talks at the COP and a copy of the Number Talks Build Numerical Reasoning Article was provided to SEAC members (See Appendix A). The article addressed techniques and examples of teaching mental math and computation strategies for students to use to solve mathematical problems. The article helped to identify some best practices in supporting students learning mathematics. 'Number Talks' book by Sherry Parrish was purchased for each SERT through funds from the Special Education Department and the Student Achievement budget.

In an effort to continue to address the Board's Special Education goals around building capacity in the area of self-regulation and in being responsive and reflective practitioners, Carmen shared two upcoming face-to-face seminars taking place in Toronto, ON. Dr. Stuart Shanker has teamed up with Dr. Susan Hopkins to offer 'Pulling Back the Veil and Responding to what we Find Beneath' on December 6 and also 'Stress Management as a Distributed Social Phenomenon' on December 7. This professional development opportunity was offered to all Principals/Vice-Principals, System level Special education and student achievement members and SERTs to attend with expenses being covered by the Special Education Department.

6.2 Superintendent of Education

Superintendent Shypula shared that the Board is currently developing a new 2018-2023 multivision accessibility plan to be compliant with current Accessibility for Ontarians with Disabilities Act (AODA) regulations. The revised plan will include a review of website, facilities, etc. and identifying barriers in order to be in compliance. Superintendent Shypula noted that the hope is to have the comprehensive plan drafted by the end of December 2017 and subsequently vetted by various stakeholders for review. The final draft would be submitted to the Board in the Spring of 2018.

Superintendent Shypula updated on the draft policy and resource guide on Special Education in Ontario for Kindergarten to Grade 12 students released in August 2017. Soliciting feedback from the public and key stakeholders, the guide now provides more comprehensive and greater consistency in the legislation, regulations, policies and program planning related to the education of students who require special education programs/services. Additionally, the Ministry will be garnering feedback from sector and stakeholder groups to inform on future revisions of the Identification Evaluation Plans (IEPs) and related content. On December 6, 2017, Superintendent Shypula and Carmen McDermid will be attending a Working Together: Regional Dialogue focusing on information about the recently released resource and upcoming supporting resources. Through facilitated discussions, it will give the district the opportunity to think about implications for this resource in improvement planning, equitable and inclusive practices and supporting positive learning environments.

Superintendent Shypula provided updates on Ontario's Education Equity Action Plan (OEEAP) released in September 2017. Equity is a central pillar of the Ministry's vision for education and it stems from the fundamental principal that every student should have the opportunity to succeed personally and academically, regardless of background, identity or personal circumstances. The Ministry released *Realizing the Promise of Diversity, Ontario's Equity and Inclusive Education Plan* in 2009, requiring Boards to create policies and administrative procedures to ensure equity and inclusion in all schools. To promote the goals found in this document, the Ministry released the OEEAP, which celebrates the great work already completed across the province, outlines next steps to eliminate barriers and enables more students to reach their full potential. To assist in realizing the goals set out in the OEEAP, the Ministry has created the Education Equity Secretariat to work with Boards to bridge gaps and address disparities in achievement.

7. Closing Remarks/ Adjournment

Superintendent Shypula prompted members to the upcoming SEAC Christmas breakfast flyer, which will be taking place in December and thanked the group for their attendance and continued meaningful input. Chair Esposto noted to have the committee terms of reference included on an upcoming agenda for review. The meeting adjourned at 11:40 am.

MENTAL HEALTH STRATEGY UPDATE

Public Session

BACKGROUND INFORMATION:

Responding to concerns expressed by district school boards across the province about the growing mental health needs of students, the government initiated the Minister's Advisory Group on Mental Health and Addictions in May 2009. As a direct result of this preliminary work, *Open Minds, Healthy Minds*, a comprehensive, cross-ministerial Mental Health and Addictions Strategy for the province of Ontario was introduced in 2011. The strategy continues to include the involvement of the Ministry of Children and Youth, the Ministry of Health and Long-Term Care and the Ministry of Education.

The key commitments to the Strategy from the Ministry of Education were as follows:

- enhance expectations related to mental well-being within the Ontario Curriculum;
- develop a K-12 Resource Guide;
- provide support for professional learning in mental health for all Ontario educators;
- fund and support Mental Health Leaders; and
- implement School Mental Health ASSIST.

The initial strategy was rolled out over three years beginning in the fall of 2011. At this time, 15 district school boards were funded to hire Mental Health Leaders. All 72 boards in the province were funded and engaged in the strategy by the end of June 2014.

The Ministry of Education continues to promote their ongoing commitment to well-being. In April 2014, the release of *Achieving Excellence: A Renewed Vision for Education in Ontario* identified Promoting Well-Being as one of the four renewed goals for education. Supplementing the Renewed Vision is a discussion document titled, *Ontario's Well-Being Strategy for Education*, which was released in the spring of 2016. The discussion document articulates a draft definition of well-being for education, and the four key components at the foundation of Ontario's well-being strategy. These four components are Equity and Inclusive Education, Safe and Accepting Schools, Healthy Schools and Positive Mental Health. A link to both documents is noted below₁. The discussion document will continue to inform the professional learning of educators and support teams in promoting and supporting the healthy development of all students.

As schools play an important role in promoting positive mental health, identifying students in need, and in supporting those who require intervention, the Ministry of Education has been a key partner in carrying out initiatives in support of the goals.

DEVELOPMENTS:

The Board's Mental Health Lead, Dianne Wdowczyk, was hired in August 2013. Funding for Mental Health Leads has been included in the Grants for Special Needs (GSN) budget since 2014-15.

The 2016-17 school year was a consolidation year of Phase 1 of the Mental Health and Addictions Strategy. As a result, to better understand how students and schools are being supported in the area of mental health and addictions, the Ministry requested the following deliverables from Mental Health Leaders:

- Three-year Mental Health Strategy (and one-year Action Plan)
- Clearly articulated youth suicide prevention, intervention and postvention protocol
- Well-articulated internal and external pathways to, from and through services for mental health and addictions services
- Evidence of board-level, and ideally school level mental health leadership teams, complete with terms of reference where available

With the support of School Mental Health ASSIST (SMH ASSIST), a provincial implementation team designed to help Ontario school boards build professional capacity to promote mental health for students, the Board Mental Health Steering Committee and the Student Support Services team, all deliverables including evidence of school level mental health leadership teams and terms of reference for the board-level leadership team were submitted as requested in June 2017.

The 2017-2020 Mental Health and Addictions Strategy and yearly Mental Health Action Plan was created and submitted following the completion of the 2014-2017 plan. This comprehensive plan reflects strategic themes which align with the overarching goals of the SMH ASSIST Provincial Strategy, but addresses the specific needs identified in our school communities. The themes include:

- Organizational Conditions
- Building Educator Mental Health Capacity
- Implementation of Evidence Based Mental Health and Well-Being Promotion
- Support for Specific Populations, including Early Years, FNMI, and LGBT youth
- System Coordination.

The work of our Board continues to be guided by the support of our SMH ASSIST coach, Lesley Cunningham, who meets with the Superintendent with responsibility for Mental Health and the Mental Health Lead several times during the course of the year.

The Board's Mental Health & Addictions Strategy 2017-2020 and the yearly Action Plan will continue to be reviewed quarterly at the Mental Health Steering Committee meetings.

A summary of outcomes from the Year 3 (2016-2017) Action Plan, *Promoting Student Well-Being: School Mental Health - Progress Report, June 2017*, is attached.






Renewed Math Strategy (RMS) STUDENT ACHIEVEMENT UPDATE

Public Session

BACKGROUND INFORMATION:

The Ministry of Education Renewed Math Strategy was introduced in 2016 and includes the following directives:

- **1.** Increased student achievement, well-being and engagement in mathematics:
- 2. Increased educator math knowledge and pedagogical expertise;
- Increased leader use of knowledge of effective mathematics pedagogy to provide the necessary supports and conditions for school and system improvement;
- 4. Increased parent engagement in their children's mathematics learning.

Our goals continue to be improving student learning and achievement in mathematics and increasing and enhancing principal and teacher learning in mathematical content knowledge and instruction. The collective work of the district continues to focus on the Fundamental Principles for Student Achievement identified in the Board Improvement Plan for Student Achievement (BIPSA):

Educators are responsive practitioners who seek first to know their learners and design instruction and assessment to meet the precise needs of each student

Educators make regular, intentional use of Assessment for and as Learning to improve student learning

DEVELOPMENTS:

In the area of Student Achievement in Mathematics, we continue to implement several initiatives that are embedded in the Board Improvement Plan for Student Achievement 2017-2018. Below is a table that outlines the initiatives and their status:



You can see that in total, 532 educators responded to the survey. We can note the following:

- 516 educators (approx.. 97%) noted increase in understanding of the content related to computational fluency or fractions
- 512 (approx.. 96%) indicated an increase in their confidence to now take the concepts and apply them to their practice
- 500 (approx.. 94%) said that their motivation to use the content, tools, and techniques had increased

STUDENT TRUSTEE REPORT

Public Session

BACKGROUND INFORMATION:

The Student Senate did not meet during the month of December.

DEVELOPMENTS:

Senators will continue preparing for the upcoming February leadership retreat.

SCHOOL NEWS:

St. John's College is continuing their work on their annual Angel Campaign to raise money for families in their area who might otherwise go without during the Christmas season. They are embracing the joy of the season through their 12 Days of Christmas events, including lunch-time activities. Students are particularly excited for an upcoming basketball game between students and teachers. St. John's Student Council is in the process of planning activities for their final day of school before the Christmas break, which will include a turkey lunch, Christmas liturgy, and a Spirit of Christmas assembly.

Assumption College has been welcoming the Spirit of Advent season through their work on their Pennies from Heaven and Tree of Hope campaigns which support families in their community.
