# 5. Committee and Staff Reports

# 5.1 Primary and Junior/Intermediate Class Size

Superintendent Keys presented the Primary and Junior/Intermediate class size report. He indicated that Memorandum 2019: SB14, requires school boards to submit detailed reports of their elementary class size date by October 31 of each school year and that the Board established class size compliance on the September 19, 2019 count date and the data had been submitted to the Ministry. He explained that it was a collaborative process involving the senior administration team and the administrators and no follow-up had been received from the Ministry yet.

In response to trustee inquiries on a portable being placed at Christ the King school, Superintendent Keys indicated that the portable was placed after taking space into account and this was not related to class sizes, and that the students were using the library and other reallocated spaces until the portable was moved.

The trustees also commended the Senior Administration team on getting the right numbers for the class size, as this would help develop staff competence and confidence in the future.

# 5.2 Ontario Catholic School Trustees' Association Annual Membership Fees

Chair Petrella reviewed the fee structure used to determine the annual membership fees with the provincial Trustees' Association. He indicated that the fee was calculated on the base amount, student enrolment in 2018-19 and special FA.C.E. levy for promoting and protecting Catholic education and that the fee was set out in Regulation 2016/15 and included in the GSN allocation.

# 5.3 Programs for Students with Autism

Superintendent Shypula explained the significant evolution that has taken place over the last 10 years in the province with respect to supporting students with autism. She noted that there are currently 181 students with autism in elementary and secondary schools across our system and provided an overview of the work being done by Ms. Donohue, Ms. Klinck and the support staff to support these students. She highlighted the ongoing training being provided to school staff, including Principals, Teachers, Educational Assistants and the Applied Behavior Analysis (ABA) team. She indicated that to date, 38 students, schools and families had participated in the Connections for Students model. With the recent Ministry funding changes and as per the Child Treatment Centre (CTCs) knowledge, students will continue to receive IBI services until March 2020. She noted that implementation of the After Schools Skills Development Program will be done based on the parameters established by the Ministry of Education and that the funding for this program extends to June 2022.

In response to trustee inquiries on the training opportunities to the educators, Superintendent Shypula indicated that the Geneva Centre for Autism Summer Institute offers free online series for educators on their website and that professional learning for educational assistants during Professional Activity days would focus on ABA strategies and evidence based content in alignment with the Geneva guidelines. She also indicated that the ABA leads function as resources; and recognizing the need for additional support, screening for the third ABA position had begun. The trustees noted the increase in the number of students over the years.

# 5.4 Excursion – Germany, Czech Republic, Poland and Hungary

Superintendent De Rubeis, presented a request from Assumption College School for an excursion to Germany, Czech Republic, Poland and Hungary from Friday, June 26, 2020 to Sunday, July 5, 2020. Students will have the opportunity to gain a deeper understanding of Eastern European culture and history. The tour will also provide the attendees insights to social, economic and political conditions that existed during the Cold War, the advent of the nuclear age as well as what led to the fall of communism in the late 1980's and early 1990's. He indicated that no class time will be lost and that the trip was part of a one credit summer school course, CHT 30. He responded to trustee inquiries on staff supervisors and the summer school course duration and indicated that once the students return from the excursion, the remainder of the course would be completed online, to be concluded at the end of July 2020. Discussion ensued about the cost of the trip. In response to trustee inquiries on security measures for student safety, and paid supervisors, Superintendent De Rubeis indicated that he would bring further information to the Board.

Director McDonald presented the Health and Safety update. He indicated that the Board considers the Health and Safety of all its employees as important. He noted that the report identifies the committee members and gives a snapshot of the accidents and the incident reports that were submitted. The Appendixes provided a comparison on the Employee Accident/ Incident statistics from September 1, 2018 to February 28, 2019 and from March 1, 2019 to August 31, 2019. He explained that our statistics are in accordance with provincial experience. He noted that like all other boards there was an increase in the incidents of student aggression; and the plan was to bring the annual data to contextualize what those incidents were to facilitate comparison between the categories and what statistics bear. He also responded to trustee inquiries on employee aggression, traumatic events and incident types.

# POLICY RENEWAL PROCESS

**Public Session** 

# **BACKGROUND INFORMATION:**

Under 169(1)(d) of the Education Act, all school board's have the responsibility to develop and maintain policies which serve to aid student achievement and well being, create a positive learning environment, ensure effective stewardship and to deliver effective and appropriate educational programs to its pupils. Policy should be clear and accessible and help to clarify practice and to reduce the risk of liability. They should be reinforced by procedures which further identify the standards at the board and school level.

# **Bylaws**

Pursuant to the provisions of the Education Act and regulations, Bylaws regulate the powers and responsibilities of the board and its officers and committees.

## **Policies**

Policies refers to the sets of rules and directives that direct the board of trustees and the staff of the board. The policy statement is a clear, concise statement of position or direction of the board. The procedure (if included) provides clear direction to staff in addressing the intent of the policy statement.

## **Procedures**

Procedures are a set of rules and directives that the staff of the board follow with respect to operational and administrative functions.

# **DEVELOPMENTS**:

In an effort to ensure that policies and procedures are current with changing legislation and Ministry expectations and initiatives, as well as relevant in the changing context of education, all policies and procedures will be placed on a four-year revision cycle. Depending upon the nature of the policy or procedure, this review could prompt a comprehensive change to the policy or no changes at all. In the spirit of collaboration, and to ensure that all educational stakeholders have input to and an awareness of board policy, the review cycle will contain a feedback process whereby all stakeholders will have the ability to provide input. The schedule for renewal does not preclude the need to change the schedule if needed. From time to time there will be circumstances which dictate that a particular policy review will need to be expedited and in those cases, this process can be pre-empted.

### **Review and Revision Process**

- 1. Policies and Procedures are to be reviewed on a four-year schedule.
- 2. When a bylaw, policy or procedure is scheduled to be reviewed it will come to policy committee with any appropriate revision prior to being circulated to stakeholders.
- 3. Revised Bylaws are brought to the policy committee then the appropriate board meeting for review and approval.
- 4. Policies and Procedures shall be brought to the board for review. The Policy Committee will approve the circulation to stakeholders.
- 5. Policies and Procedures shall be circulated to all stakeholders for a minimum of 60 days, for input with respect to revision.
- 6. At the end of the circulation period the superintendent responsible for the policy or procedure will make the revisions, then bring a report to the first available committee of the whole for discussion, then approval at the Board meeting.
- 7. If the policy or procedures has been modified to a large degree as a result of the consultation process, the policy or procedure will be brought back to the Policy Committee before going to the Committee of the Whole.
- 8. If, after the stakeholder input period, there are only a few revisions to the policy or procedure, it will be brought directly to the Committee of the Whole.
- 9. All revised Bylaws, Policies and Procedures will be posted on the Board's website.

# ONTARIO CATHOLIC SCHOOL TRUSTEES' ASSOCIATION – ANNUAL MEMBERSHIP FEES

# **BACKGROUND INFORMATION:**

The Ontario Catholic School Trustees' Association (OCSTA) continues to be a strong guiding and unifying force for Catholic education in our province, as they are represented at a number of key government tables and work with partner organizations to promote and protect Catholic education. On a yearly basis, the Board has remitted a membership fee.

# **DEVELOPMENTS**:

The annual fee for our Board is calculated on a base amount of \$8,160 plus a cost of \$3.805 per student. Based on our 2018 -19 student enrolment of 10 003 ADE (Average Daily Enrolment), the membership fee for this year is \$46 221.00

In 2013-14, a special F.A.C.E. levy for promoting and protecting Catholic education was introduced and this levy will continue for 2019-20. The levy is calculated at 12 cents per pupil, for a total of \$1 200.36. HST does not apply to either the Membership Fees or the F.A.C.E. Levy.

Under the School Boards Collective Bargaining Act OCSTA continues to serve as the designated bargaining agent for its 29 Catholic District School Boards. The fee is set out in Regulation 206/15 and was included in the GSN allocation. The amount for the 2019-2020 school year is \$43 017.00.

# **RECOMMENDATION:**

# EXCURSION – GERMANY, CZECH REPUBLIC, POLAND AND HUNGARY

**Public Session** 

## **BACKGROUND INFORMATION:**

Assumption College School is requesting approval for an excursion to Germany, Czech Republic, Poland and Hungary from Friday June 26, 2020 to Sunday July 5, 2020 (no school days missed as this is at the end of the school year). This trip is part of a one credit summer school course, CHT 3O – World History Since 1900 – Global & Regional Interactions. Once the students return from the excursion, the remainder of the course will be completed online and is scheduled to conclude at the end of July 2020.

Staff supervisors will include Ms. Terry MacKinnon, Mrs. Susie Picanco, Mr. Ryan O' Donoghue and Mr. Laurence McKenna. The cost of the trip is approximately \$4,053.00. The tour is being organized by Explorica Canada Inc.

# **DEVELOPMENTS:**

Approximately twenty-five (25) Grade 11 students from the *Canadian and World Studies Department* will travel by plane to Berlin, Germany to begin an educational excursion of Germany, Czech Republic, Poland and Hungary. This tour provides an excellent opportunity for students to gain a deeper understanding of Eastern European culture and history. This tour will address several of the curriculum expectations that are identified in the course including: the rise of empires in the late 19<sup>th</sup> and early 20<sup>th</sup> century in Eastern Europe, the forces that imperialism and nationalism had on the rise of World Wars I and II and the adverse impact these events had on the population's identity and citizenship rights. The tour will also provide the attendees insights to social, economic and political conditions that existed during the Cold War, the advent of the nuclear age as well as what led to the fall of communism in the late 1980's and early 1990's. How these countries and societies have redefined themselves politically, socially and economically to compete globally in a free market will also be explored.

The students will participate in guided tours in Berlin, Prague, Kraków and Budapest and visit numerous sites such as; the Berlin Wall, Auschwitz Concentration Camp and Memorial and various other Museums and palaces. Students and staff will strengthen their faith by attending mass at the largest and most important temple in Prague, St. Vitus Cathedral which apart from the religious services, is a place of burial of several patron saints, sovereigns, noblemen and archbishops.

All information has been provided in accordance with Board policy and procedures.
