Superintendent Temple reviewed the Right to Read public inquiry report on human rights issues affecting students with reading disabilities, such as Dyslexia from the Ontario Human Rights Commission. The report included detailed findings and recommendations for the Ministry of Education, school boards, and faculties of education on curriculum and instruction, early screening, reading interventions, accommodation, professional assessments, and systemic issues. A summary of the recommendations was shared. An outline of local next steps was provided including implementing standardized screening for Grade 1 students, the purchase and use of the Heggerty program, professional development for staff, developing plan with Special Education, seeking more resources.

# TRUSTEE DETERMINATION AND DISTRIBUTION - 2022 ELECTIONS

Public Session

#### **BACKGROUND INFORMATION:**

The municipal elections to be held in October 2022 will include the election of school board trustees. In preparation for the election, school boards are required to determine the number of trustees to be elected and the distribution of those trustees as allowed under Regulation 412/00 of the *Education Act*. In addition, school boards must determine whether to designate a trustee to low population areas. The rationale for designation of a trustee to low population areas is to ensure representation in areas in which there may be insufficient population to justify a trustee based solely on the calculation.

The *Education Act* allows district school boards to reduce their number of elected members below the number provided for in the Act and Regulation 412/00, but not below the minimum number of five members. This can only be accomplished by a resolution of the school board. If a school board chooses to exercise this option, the resolution must be passed before March 31<sup>st</sup>.

#### **DEVELOPMENTS:**

The Brant Haldimand Norfolk Catholic District School Board has four municipalities:

➤ The City of Brantford and the Counties of Brant, Haldimand and Norfolk.

The Board must approve the following:

#### 1. The Number of Trustees According to the Population of the Electoral Group:

 As the Brant Haldimand Norfolk Catholic District School Board has an electoral population less than 45,000, the number of trustees for the Board is six. (Regulation. 412/00).

#### 2. Low Population Representation:

 Based on the distribution, there is no need to designate a trustee to a low population area.

#### 3. The Distribution of Trustees:

 Attached, as Appendix A, is a spreadsheet, which indicates the proposed allocation and comparisons back to 2010.

#### CHANGE OF BOARD MEETING DATE

#### **BACKGROUND INFORMATION:**

For the past two years secondary schools have not been able to hold face to face graduation ceremonies as a result of the COVID pandemic. Prior to COVID these graduation dates were scheduled well in advance so that the date could be coordinated with Senior Team and the Board calendar to ensure that there was not a conflict. With the reopening plan from the province, this advance booking was not possible. As a result of time and scheduling constraints the only time that St John's College was able to book their venue, and not be in conflict with Assumption College School's graduation, was on the same date as the June Board meeting.

#### **BACKGROUND INFORMATION:**

The Board of Trustees approved Policy 700.01 Procurement which promotes and outlines procurement processes and decisions consistent with the ethical and strategic objectives of the Board, the Broader Public Sector Accountability Act and other applicable legal requirements and applies to all staff wishing to procure in the course of performing recognized duties and responsibilities.

To meet the requirement of the Policy, a quarterly report is presented to the Board of Trustees for information on all cooperative purchasing agreements. This report will also list all contracts approved by the Board in accordance with Policy 700.01.

#### **DEVELOPMENTS:**

The Board actively participates in cooperative procurement ventures with other school boards and other branches of government or their agencies of public authorities (i.e., Ministry of Government and Consumer Services or the Ontario Education Collaborative Marketplace) to obtain maximum value for money through economies of scale and/or shared services. This may also include the Board utilizing a piggy-back clause to existing Ministry or government services, district school boards and/or other cooperative group contracts, to the extent permitted by applicable law.

### PROCUREMENT POLICY 700.01

Public Session

#### **BACKGROUND INFORMATION:**

In February 2020, the Board of Trustees approved the revised Procurement Policy 700.01 through the Board's policy review process.

Included in the policy is an Approval Authority Schedule (AAS) outlining the approval levels to be obtained prior to conducting purchases or engaging is services.

The purpose of this report is to obtain approval to the proposed amendment to the AAS based on changing operational needs of the Board.

#### **DEVELOPMENTS**:

Facility Services repairs, remodels, and provides daily, weekly, monthly preventative maintenance for the 28 elementary school, 4 secondary schools, and 3 administrative buildings. In addition, the Facility Services assists departments with various special events and projects.

To fulfill the department objectives and ensure our students, staff, and visitors continue to enjoy safe and healthy learning and work environments, Facility Supervisors are regularly required to incur smaller value purchases for parts or services. The current AAS does not provide for Supervisors to approve payment of such transactions.

In order to ensure continue efficient services provided by the department and payment to vendors, the following amendment is being proposed to the AAS:
