5. Committee and Staff Reports

5.1 Family Life Programming

Superintendent Temple provided an overview of Elementary Family Life Education. An outline of Gender Identity in Family Life Education was shared. It was noted that in the Ontario Health and Physical Education Curriculum Policy Document, 2019, the word gender or gender related terms are found 137 times and 56 of those are in the glossary and appendices. The use of these terms is not part of curriculum expectations, they are made in the preamble to lessons or other sections directed to the teacher for consideration when planning their lessons/programming. The curriculum also facilitates discussions for students to talk about special dignity, sharing differences and respecting differences, and the terms gender identity and gender roles and expression are shared. Superintendent Temple advised students from Grades 1-8, are taught that they are created in the image and likeness of God - male and female. That they possess the ability to love and co-create in a loving, committed relationship that the sacrament of marriage offers and affirms.

5.2 French as a Second Language (FSL) Update

Director McDonald provided an update regarding the shortage of French teachers. Staff have continued to exhaust all options to continue to offer Core and French Immersion and address staffing needs. A summary of options to address the needs were shared including the following:

- Work on a school-by-school basis with those experiencing staffing pressures in French (12) to offer Grades 4 to 8 Core French Program as mandated by the Ministry of Education.
- Remove Core French from Grades 1 and 2 across the district (November 2022)
- Remove Core French from Grades 1 to 3 (September 2023)
- Starting French Immersion in Grade 1 (September 2024)



It was noted that the board continues to actively recruit and collaborate with Teacher's Colleges and other partnerships, to share the Board's French programs. After carefully considering the options noted above, staff recommends that the Board work on a school-by-school basis with those experiencing significant staffing pressures in French, to offer only the mandated Grades 4 to 8 Core French Program. Superintendent Temple highlighted this option as the least disruptive to the lowest number of students and staff. She also provided an outline of how schools would be supported in the staffing change process and with communication to share with school communities.

FRENCH AS A SECOND LANGUAGE (FSL) UPDATE Public Session

BACKGROUND INFORMATION:

The Brant Haldimand Norfolk Catholic District School Board offers a vibrant French Immersion and Core French Program for students across the district. To sustain the outstanding programs, we need to look at one of the obstacles standing in our way of continuing to offer this incredible programming for our students.

Over the past few years, we have been faced with a challenge of finding enough competent French qualified teachers to teach and instruct our French Immersion and our Core French Programs. Over the last few weeks, recruitment of French qualified teachers has been a focus for our Human Resources Department as well as our Student Achievement Consultant for French and the Superintendents responsible for French and staffing.

INFORMATION GATHERING:

Student Achievement and Human Resource personnel have been meeting over the past two years to brainstorm ways to continue offering a vibrant French program in both Core and French Immersion, as well as address all staffing needs, especially in French.

We have a few options to consider addressing our French staffing and programming needs that have emerged:

1. Work on a school-by-school basis with those experiencing staffing pressures in French (12) to offer Grades 4 to 8 Core French Program as mandated by the Ministry of Education.
 - Thus far we have implemented this in a few buildings and have had staff and parental support
 - Offered communication for administration to share with school communities
2. Remove Core French from Grades 1 and 2 across the district (November 2022)
 - With further information and deeper discernment, this approach may not solve our concerns in two schools without transferring staff
 - Would impact 27 educators
 - The impact would be on all 28 sites regarding various schedules across each school community as well as prep courses being offered in each school
 - This would involve moving approximately 17 FSL (French as a Second Language) teachers to different schools or different teaching assignments mid-year
 - This would result in approximately 6 French teachers having to pivot to teaching English courses (teaching outside of their areas of expertise in a class that they had been teaching French in the day before)

3. Remove Core French from Grades 1 to 3 (September 2023)
 - Allows us the time to carefully plan and communicate the change
 - We can ensure that the prep coverage occurs as we need it to occur (not literacy, religion, or numeracy)
 - Allows equity of roll out across the system (all 28 schools teaching Grades 4 to 8 French at the same time)
4. Starting French Immersion in Grade 1 (September 2024)
 - Allow the foundational development of the English language with consideration of the Science of Reading work and the importance of reading and literacy
 - September 2025, French Immersion would begin in Grade 1
 - Work alongside Grand Erie to communicate and begin this change at the same time

In addition to these considerations, we will also continue actively recruiting, collaborating with Teacher's Colleges and other partnerships, to leverage opportunities to share our Board's French programs and entice French teachers to apply to BHNCDSD. We also have a pilot project running with Laurier Brantford to offer French as a Second Language for free, as we have the past two summers, to further support teachers becoming qualified to teach French within the BHNCDSD.

DEVELOPMENTS:

After investigating the above scenarios, we are recommending that the Board work on a school-by-school basis with those experiencing significant staffing pressures in French, to offer only the mandated Grades 4 to 8 Core French Program. This results in the least disruption to the lowest number of students and staff. Schools would be supported in the staffing change process and with communication to share with school communities. Taking this approach would require a process that is unique to each school situation. A school community, in this situation, may have to employ one or more of the following remedies or other remedies not listed:

- Collapse FSL Programming in either Grade 1, 2, or 3 or in all three grades and replace with English Prep
- Change French Teacher's assignment from primary to junior/intermediate in their school
- French qualified Teachers, currently in an English assignment, would be changed to teaching junior/intermediate French in their school
- French qualified Teachers, currently teaching an English course, are transferred from one school to another to teach junior/intermediate French

The Board would then plan for the elimination of Core French from Grades 1 to 3 beginning in September 2023.

TRUSTEE HONORARIA

BACKGROUND INFORMATION:

Ontario Regulation 357/06 - Honoraria for Board Members sets out the method for calculating the limits on honoraria paid under section 191 of the Education Act. The honoraria, in respect of any year of the term in office, consists of the following components: base amount, enrolment amount, and Chair/Vice Chair amounts, as outlined in Board Policy 100.06 – Trustee Honoraria.

DEVELOPMENTS:

There have been no changes to the base amount for trustee honoraria. For the term of office starting November 15, 2022 to November 14, 2023, the only change to trustee honoraria will be the impact of enrolment changes.

Trustees are now paid bi-weekly by direct deposit based on 1/26 of the established honorarium.

The calculation for the trustee honoraria for the period November 15, 2022 to November 14, 2023, is detailed in the chart below, which does not include the student trustee.
