Information Report on Student/Math Achievement Plans

Public Session

BACKGROUND INFORMATION:

Last spring and summer the Ministry of Education released their requirements for a Math Achievement Action plan and a memorandum communicating key regulatory and policy reforms in support of Better Schools and Student Outcomes Act, 2023. Including a new regulation on provincial priorities in the area of student achievement:

- 1. Achievement of Learning Outcomes in Core Academic Skills
- 2. Preparation of Students for Future Success
- 3. Student Engagement and Well-Being

The Ministry recently released pre-populated materials that we are to use to support the development and public reporting of data as well as board action plans on student achievement. The data includes: EQAO data, credit achievement for our secondary students, suspension, and attendance data. Once the report is created, it will be presented to the Board at the March Board meeting before being publicly shared by April 2, 2024, as per Ministry direction.

The Student Achievement Plan crosses many portfolio areas: Curriculum, Student Success, Special Education, Mental Health, Equity, Indigenous Education, and Attendance.

Part of the development of the plan is to include community partners to support levelling up of student outcomes. Moving forward, we are required to engage with families and stakeholders in the fall to share the plan and in the late spring before June reporting to the Ministry of Education. In addition, a separate Math Achievement Action Plan is to be shared three times a year with the Board and our stakeholders.

DEVELOPMENTS:

On April 2, we are to publicly report on the BHNCDSB website the data shared by the Ministry and Action items to address the data. The information that will be publicly available based on EQAO scores as well as enrolment data for math and science courses beyond what is mandatory, success in credit attainment by the end of Grade 10, and graduation rates will be shared at the Board meeting. At this point in time, BNHCDSB is not reporting on any additional school board measures or on priority groups until we can determine how to accurately capture that data, ensure its validity, and its impact for our work.

We continue to focus on math learning and monitoring at monthly AAC meetings supporting a shift in culture, building capacity, with a focus on high impact strategies such as small group instruction, use of math conversations through daily number talks and routines, as well as making learning visible.

Last month, it was shared that a letter would come to the Director regarding our initial plan submitted in November. It did and the Ministry Math Team shared:

Thank you for submitting your Math Achievement Action Plan. The ministry appreciates the focus and attention evident in your plan, including the following areas:

- A clear connection between all three priority action areas of the Taking Action in Math Framework.
- The Priority Schools Report has specific and identified areas of need, such as computational and multiplicative thinking.
- Support for educators is clear in making connections between the use of High-Impact Instructional Practices and the use of math processes utilized in classrooms.

The interim plan is to be submitted by the end of this week and highlights our progress regarding the implementation and monitoring of specific key performance indicators. We continue to work on further ways to quantify the impact of an increase in educators' use of assessments and subsequent impact on student learning and achievement. Our Progress Report indicates an increase in the use of diagnostic tools and resources (including digital tools such as Knowledgehook); increased use of three specific high impact strategies (math conversations, small group instruction, and use of visual tools and representations); and an increase in Principal professional development and monitoring suggestions via monthly AAC meetings. Challenges remain the inability to offer formal, job-embedded PD due to staffing shortages to provide learning on the use of EQAO data and diagnostic assessment to inform instruction; as well as fidelity to the curriculum; and limited number of facilitators to provide support outside of the priority schools to grow and sustain the learning system wide. Further learning and PD on EQAO and diagnostic data to inform instruction, will be the focus of the plan in 2024-2025.

Alongside the execution and monitoring of the Math Achievement Action Plan, is the direction to revisit the Indigenous Action Plan, Special Education Action Plan, Mental Health and Addictions Strategy as well as the Equity Action Plans in the development of the three-year Student Achievement Plan and seek stakeholder feedback. At the Regional Parent Meeting March 25, I shared the Student Achievement Plan and sought feedback via that forum and created a survey to be shared out and completed over the next few weeks to support the Ministry report completion for June 2024. The report that will be shared publicly on April 2 on our Board Website will first be shared at the March Board meeting. The data that will be shared was populated by EQAO. Our team provided all the action items implemented and focused on this year as noted in the last column of the report.

In the Fall, through RCPIC and under Superintendent Della Fortuna, an in-person meeting to seek more fulsome input and feedback from all stakeholders on the Board Student Achievement Plan, is being organized.

The Student Achievement Plan will be reported to the Ministry on June 30. This reporting cycle will repeat in April and June for the next three years. Each plan and follow up report, will be shared at the Board meetings in March and June.

DEVELOPMENTS:

The Student Senate held its last meeting on March 19th, 2024 at 4pm via TEAMS, where senators brainstormed potential student council retreat ideas, as well as shared information about their respective student councils' upcoming events.

SCHOOL NEWS:

March has been a slow month at St. John's College. On March 4th, the SJC boy's and girl's varsity hockey teams faced off against the teachers in a staff versus students hockey game, after school at the Wayne Gretzky Center. During the school day on March 4th, SJC students wore jerseys in memory of Walter Gretzky. During the March Break, two groups from SJC participated in international excursions. STEM club visited Costa Rica and Panama, and the Visual Arts Department visited Italy, France, and Monaco. Furthermore, SJC students and staff wore fun socks on March 21st, to mark World Down Syndrome Day. Campus Ministry at SJC also held a Lenten food drive, to collect non-perishable food items and household items for St. Vincent de Paul. In April, SJC will celebrate Easter with a mass, as well as hold its annual spring pep rally.

At Holy Trinity, the Student Council's biggest activity for the month of February was the Valentine's Spirit Week. This week consisted of a red, white, and pink spirit wear day, trivia over the announcements, and activities at lunch in the lower cafeteria, all spread throughout the week. In the month of March, Holy Trinity's council has not carried out any activities as they end their 2023 - 2024 term and enter the 2024 – 2025 term.
