5. Committee and Staff Reports

5.1 Insurance Renewal

Superintendent Nelson presented the Insurance Renewal report. The Board's property and liability insurance is currently covered by the Ontario School Boards' Insurance Exchange (OSBIE), which is a reciprocal cooperative established in 1987. OSBIE insures most school boards and several joint ventures in Ontario. As of January 1, 2026, OSBIE is in the final year of the current five-year Subscription Period, which ends on December 31, 2026. In addition to their regular insurance program, OSBIE provides an incentive program to help reduce fees even further. Overall premiums are set by OSBIE's appointed actuary to ensure sufficient funding for anticipated future claims, and premiums fluctuate annually based on several factors. As a subscriber, OSBIE provides additional value by returning premiums based on the pool's experience. In 2025, the Board received a premium refund of \$40,581, excluding PST.

After the winner is determined, the Chair of the Board will announce the name of the successful candidate and request a motion to confirm the voting results. The successful candidate will be appointed to the role and will be sworn in prior to the conclusion of the meeting.

The total cost of the project was discussed, which includes the land purchase and contingency fund. The tender for construction has been awarded and when the design plans have been finalized, they will be shared with the Trustees. Discussion was had surrounding the role that Trustees play in a new school being built. Trustees are involved in the tendering process to fulfill their fiduciary duties, but not the design phase as it falls under operations. There are no new updates regarding the two new elementary schools.

6.2 Attendance Boundary Review Updates

Director McDonald presented updates regarding the attendance boundary reviews. He noted that this is a busy year as three boundary reviews are taking place simultaneously (City of Brantford elementary, Brant County elementary and Brant/Brantford secondary). The first three committee meetings are complete for all three boundary reviews. The committees consist of parent representatives from the schools impacted. The public meeting for the City of Brantford is Monday December 1, 2025, and various options will be presented. The messaging continues to be that this is still very early in the process. The public meeting for the Brantford/ Brant County secondary school boundary review and the Brant County elementary school boundary review will take place in the new year. Discussion regarding the information that is shared at the public meetings was had. Before the public meeting, the committee's final task is to decide which options will be presented to the public. It was noted that the final recommendation that comes to the senior team prior to going to the board of trustees is made by the committee—not by staff or external planners. Discussion regarding the selection process for school representatives was had.

BACKGROUND INFORMATION:

Elected trustees, in their role as stewards and guardians of Catholic education, are provided with resources, supports, and reimbursements to fulfill their duties, as permitted under the Education Act and the Broader Public Services Expenses Directive.

Throughout their term of office, trustees are eligible for reimbursement of expenses incurred in the execution of their responsibilities, as outlined in Board Policy 100.10 – Trustee Expenses. Eligible expenses include mileage, professional development and conference costs, office supplies, and communication support.

In accordance with Board Policy SBG #100.10 – Trustee Expenses (Section 7.7), trustee expenses are reported to the Board annually in a public session and are posted on the Board's website following the close of the previous school year's financial records.

DEVELOPMENTS:

Similarly, in accordance with *Employee Expense Policy FIN #700.04*, all staff are supported in fulfilling their duties on Board business while maintaining transparency and accountability. The policy provides clear provisions for the reimbursement of eligible expenses, including travel, meals, mileage, and hospitality, where a clear rationale and business purpose are demonstrated.

In compliance with governance review requirements, aggregate annual expenses for the senior leadership team are summarized in this report and will be made publicly available on the Board's website. These expenses have also been publicly disclosed on a quarterly basis.

Appendix A summarizes trustee expenses and senior team expenses for the period September 1, 2024, to August 31, 2025.

STUDENT TRUSTEE REPORT

Public Session

DEVELOPMENTS:

The Student Senate met on Tuesday, December 9, 2025, at Holy Trinity Catholic Secondary School to continue their collaboration and future plans. Following the meeting, the Senate facilitated the annual Fall/Winter Student Council Retreat at Holy Trinity.

SCHOOL NEWS:

Assumption College School (ACS) had a busy month of Student Council, athletic and club events leading up to the Christmas break. Student Council organized and hosted the semiformal dance on December 5. The theme of the dance was "midnight star" and the event was a success with approximately 400 students attending. Assumption also hosted its Fall coffee house in November which featured several acts and was catered by the Assumption Food classes. ACS is also preparing their annual Christmas spirit week and spirit of Christmas event.

Assumption's Vocal Ensemble and Band toured the Brantford elementary schools where they performed. ACS Prefects continue with mentor pairings helping students to improve their grades. Chess club has started up again and Math club recently wrote a math contest. Assumption also recently had its Christmas concert where the Vocal Ensemble, music classes, and Band performed different songs by the Beatles. In November, Assumption held its annual Marketplace event for the Pennies from Heaven campaign fundraising to help families who struggle financially over the holiday season.

Assumption held its Advent Prayer Service which was led by the Chaplain and the 180 Team. We also had our annual Model UN where student delegates representing different countries practiced diplomacy and passed resolutions. Assumption has also been selling poinsettias as a fundraiser for the Athletic Department to fund our various sports teams. Furthermore, Assumption hosted its Academic Awards recognizing students for excellent academic performance in the 2024-25 school year.

Assumption's Junior Girls' Volleyball has started off strong with a 4-0 record. The Girls' Basketball season ended at CWOSSA where they were defeated by Orangeville in a final close score of 51-47. Boys' Basketball has recently started with both the Junior and Senior teams starting off strong. The Girls' and Boys' Hockey teams have recently started their seasons as well.

Holy Trinity Catholic Secondary School (HT) had a busy month of Student Council, athletic and club events leading up to the Christmas break. Student Council began its recruiting process in November, and candidates were asked to either write a short essay or submit a video explaining why they would be a good fit for Student Council. December at Holy Trinity has featured Christmas events including Elf on the Shelf, Candy Grams, hot chocolate distribution and much

more. Christmas spirit days will be happening shortly inviting students to participate daily by wearing Christmas accessories, Christmas sweaters, grade assigned colours, and pajamas. Holy Trinity also had their semi-formal dance on November 13 in the lower cafeteria and the theme was "New York". The school's Academic Awards recognizing the achievement of many students was followed by refreshments and dessert, took place on November 26. Holy Trinity also had their dress down day on November 27. On December 2, Holy Trinity celebrated the Sacrament of Reconciliation in the morning, and the following day celebrated the school's Advent mass. On December 5, HT's feeder schools visited to tour the school and participate in various orientation activities like scavenger hunts. HT has their Christmas liturgy coming up on December 19 in the gym.

Holy Trinity's Girls' Volleyball team has started off strong participating in multiple games and a tournament. The Girls' Hockey team had tryouts in November and have since had multiple games and have gone undefeated. For the first time, HT is hosting two flag football tournaments on December 10 and December 12.

St. John's College (SJC) had a November filled with notable events facilitated by the Student Council, sports teams, and clubs. The Winter Wonderland semi-formal planned by Student Council was postponed to December 12 due to the snow day on November 28. Student Council worked hard to prepare for the rescheduled dance. From November 24-28, Student Council hosted student auditions for the Winter coffee house which happened December 8. Performing genres included dance, music, and drama. Student artwork was displayed during the event.

SJC's Student Council began a three-week Christmas toy drive on November 24. Homeroom classes were encouraged to bring in gently used second-hand toys to be given to families in need. Over 700 toys were donated and the homeroom that donated the most toys won a prize. Student Council has also been planning for the 12 Days of Christmas spirit days which will include Hot Chocolate Day, Football Caroling Day, and the Spirit of Christmas Day. In addition, St. John's Academic Awards Ceremony celebrated students' academic achievements in the 2024-25 school year.

The St. John's Athletic Department has welcomed this year's winter sports teams. The Curling team has had tryouts and practices at the Paris Curling Club, preparing for upcoming competitions. The Swim team also began practices and on December 4 competed in their first swim meet of the year at the University of Guelph. The St. John's Wrestling team recently competed in two competitions, winning three bronzes, two silvers, and one gold. The Jr. Boys' Basketball team and Jr. Girls' Volleyball teams have made St. John's proud remaining undefeated at the beginning of their season.

St. John's Black Student Association (BSA) has resumed and invited everyone to their first meeting on November 27. SJC's Gazette team is working hard and are almost ready to publish the first issue of the school year. In addition, the Leadership class collected Angel Campaign donations from November 21-28 and will use the money raised to provide for families in need.
