2. Committee and Staff Reports

2.1 Ministerial Governance Review Response

Director McDonald presented the second ministerial governance review response report. At a special meeting of the Board on May 13, 2025 the Board of Trustees approved the BHNCDSB's proposed first response to the Ministry Governance Review and Ministerial Action items. The Director explained that to date the Board has been able to reduce the debt to \$37,700.00 and will continue its attempts to further reduce this amount. The trustees will attempt to solicit donations from private donors, Catholic organizations and diocesan organizations. These efforts to eliminate the cost to the Board will hope to be completed by September 1, 2025.

It was confirmed that the communication to the Minister of Education will include individual Trustee names, and the amount that is repaid by each trustee to the Board as it is an individual decision. It was also confirmed that no ministry money can be used to pay for the statues, it must be collected through donations. There was discussion as to what the possible next steps would be from the minister. There was also discussion with regards to what funds the BHNCDSB could use to furnish the chapel in relation to what other Boards do.
