#### 5.2 2015-2018 Strategic Plan: Student Achievement Update

Superintendents Shypula and Daly provided an update on the work being done by the K-12 Student Achievement Team in support of improved student achievement across the district. Some of the key initiatives that were highlighted included the school-based professional learning opportunities organized in bands of leaning - Kindergarten to Grade 2 teachers, Grades 3-6 teachers, and Grades 7-10 teachers and principals – with specific areas of focus to enhance teaching practices and to build capacity; improved student diagnostics; the use of surface devices by classroom teachers and embedded technology in student learning supporting 21st century competencies; the expansion of the Bring Your Own Device (BYOD) initiative to additional schools; increased focus in the area of Grade 9 Applied Mathematics; student-driven/teacher-guided career/pathways planning; and the introduction of innovative thinking spaces in school libraries. Several trustee inquiries were addressed by Superintendents Shypula and Daly.

#### 5.3 Global South Encounter - Guatemala

Director Roehrig provided background information of developments and conversations since 2012 involving St. Jerome's University, the Diocese of Hamilton and several partnership Boards that have led to the proposal of offering a global south encounter for secondary students in 2018. Director Roehrig explained that this service learning experience directly supports the Board's spiritual theme and acts as an ideal opportunity for our students to learn more about Catholic post-secondary institutions and opportunities. He noted that significant preparation work and first-hand assessment of the quality of the experience, the merit of the work/experience, and student health and safety must be completed in the near future in order to allow sufficient time to organize and offer this encounter experience to students next year. Consequently, two staff members will be involved in a pre-site assessment with staff from St. Jerome's University and other boards next month. Trustee concerns were raised in the area of cost to the Board, ensuring the health and safety of students/staff, inclusivity, and age-appropriateness of secondary school students to experience this type of encounter. Trustees requested a presentation by someone who has been involved in this encounter in the past in order to obtain additional information.

#### 5. Presentation- Tools to Help Students Visualize Math

The Committee welcomed System Student Achievement Teacher Sue Defreyne, and Special Education Resource Teachers Jennifer Bergsma and Debbie Dignan, to discuss new tools and approaches that are being used to teach Math. A video entitled "Everyone Can!" was shared, and reference was made to Jo Boaler's extensive math research and resources. Sue demonstrated the Rekenrek tool and discussed how it has proven useful in helping students to understand number sense, to process math equations, and to be able to explain different thinking patterns. Other useful math tool demonstrations included the ten frame tool (composing and decomposing numbers), and linking cubes (adding and subtracting numbers, and using the cubes to illustrate money values). The team discussed subitizing, which is the ability to see a number of objects and know how many there are without counting. Experience in subitizing gives students the opportunity to begin developing skills in looking at larger numbers, grouping within large numbers, and being more efficient in counting. Debbie shared that many schools are hosting Family Games Nights. She highlighted an upcoming event at Jean Vanier School on May 9, which will focus on engaging students and their families with mathematics. Jennifer shared a list of resources which all Special Education Resource Teachers have received and are been trained on. Materials include those used in this presentation, and were chosen for their usefulness in making math learning more meaningful. Debbie provided the group with an overview of a workshop that she and Jennifer hosted at the recent Working Together Symposium. The session

provided parents and educators with simple and cost effective ways to engage children in math thinking and games, by using everyday household items such as ice cube trays and clothes hangers.

#### 6.1 Letter from Nipissing-Parry Sound Catholic District School Board

Superintendent Telfer shared a letter from the Nipissing-Parry Sound Catholic District School Board to the Ministry of Education addressing the reduction to the Special Education High Needs Amount (HNA), which affects all school boards differently.

#### 7. Community Agency Updates

Christine Pearce - Program Manager, Woodview Mental Health & Autism Services

Christine shared how Woodview, working in conjunction with the Canadian Mental Health Association (CMHA), are working towards raising awareness on mental health during Mental Health Week, which is the first week in May. Suggestions for the use of hash tags and advertising in key locations within our cities were offered as ways to increase engagement for mental health.

Teresa Westergaard-Hager - Supervisor, Community Outreach, Norfolk Association for Community Living

Teresa provided updates on how Norfolk Association for Community Living is currently working on strategic planning and focusing on individualized supports. The organization is seeking to fill the position of Passport Coordinator. It continues to concentrate on employment and the phasing out of sheltered workshops. They are continuing to meet with families and offer more individualized planning to connect them to specific resources within the community.

Michelle Shypula - Superintendent of Education, BHNCDSB

Superintendent Shypula thanked the SEAC committee for being welcomed to the group and the opportunity to learn more about special education. She expressed excitement to see the progress we are making and looking forward to more opportunities in the future.

#### 8. Reports

#### 8.1 Student Achievement Lead: Special Education

Carmen McDermid shared information about the collaborative working session held at the Community of Practice (COP) meeting on January 19 with SERTs, System Special Education staff and Jackie Whiting, the French as a Second Language (FSL) Consultant. As a group, they discussed the shared goals and vision of an FSL classroom, including a brief overview of the Ministry document, *French as a Second Language for All*.

Carmen also updated the group on the first of two training sessions between the Special Education Department and FSL teachers. In a feedback survey given to FSL teachers by the Special Education Department, specific areas of concern, support and/or training were identified. Based on this feedback, a half-day workshop was held on February 9, 2017 with a focus on topics considered to be a priority by the FSL teachers including self-regulation, zones of regulation, behaviour management strategies, fidget items and calming strategies for all students. The meeting included FSL teachers from all elementary schools working with

Sandra DeDominicis, school Special Education Resource Teacher, who provided training on the zones of regulations, the use of fidget items and other sensory items. A second professional development session with FSL teachers and Special Education is booked for April 4. This session will include further training/discussion on topics such as autism, writing Individual Education Plans (IEPs), as well as assessment and technology, as requested by the FSL teachers.

#### 8.2 Superintendent of Education

Superintendent Telfer discussed the Identification, Placement and Review Committee (IPRC) meetings which have been taking place as we prepare for the 2017-18 school year. IPRCs have been held at Holy Trinity Catholic High School, St. John's College and Assumption College School for students transitioning to self-contained classes at Notre Dame (Brantford) and St. Joseph's (Simcoe).

#### 1. Opening Prayer

Keri Calvesbert led the opening prayer.

#### 2. Approval of the Agenda

The agenda of the February 22, 2017 meeting was approved, as distributed.

#### 3. Approval of Minutes – November 9, 2016

The minutes of the November 9, 2016 meeting were approved.

#### 4. Information & Discussion Items

#### 4.1 Elementary Religion and Family Life Update / Social Justice Initiatives Update

Keri Calvesbert advised that 100 additional Christian Meditation home kits have been provided to elementary schools and that school visits to reinforce the practice of Christian Meditation have taken place. Keri and Paul Tratnyek are working with Secondary Religion Department Heads to support the practice of Christian Meditation in secondary schools. She also updated the Committee on the progress of the publication of a Christian Meditation book that will contain submissions from each of our schools, scheduled for release during Catholic Education Week.

She noted that the Grades 1-3 "Growing in Faith, Growing in Christ" teacher and student resources have been distributed to all schools. These resources have also been provided to parishes for use by Parish Pastoral Teams and the Hamilton Diocese is willing to assist with any training upon request. Keri shared that many elementary schools focus on a specific virtue every month; however, a disconnect exists between these virtues and the student agendas. Work is being done to revise the agendas to align with Board resources, curriculum expectations, and our Ontario Catholic School Graduate Expectations.

Keri advised that Catholic Education Week will feature the Catholic Student Leadership Awards evening, a student leadership symposium, and the launch of the St. John's Bible.

Keri also provided an update on the Elementary Social Justice Teams Formation Retreat Days and Outreach Experience Days noting the call to connect teachings of social justice to the work of justice in our schools. She shared the work being done with Catholic Service Organizations such as the Brant Chapter of the Society of St. Vincent De Paul (SSVP), and The Good Shepherd in Hamilton. All schools have been invited to participate in a "Collection of Caring Campaign" during the season of Lent. She emphasized the need for schools to understand the reasons why we give alms and to act justly during Lent.

## 4.2 Contemplative Retreats / Global South Encounter / Contemplative Prayer in Secondary Schools / Faith Day 2017

Paul Tratnyek reviewed the variety of experiences being experienced at the staff Contemplative Prayer Retreats held at Mount Mary, Ancaster (three retreats this year; maximum 20 participants). The feedback has been positive with many retreatants requesting a follow-up retreat. These retreats will be offered again next year, with consideration for system leaders and the Student Achievement Team members to attend.

Paul updated the Committee on where we are with the Global South Encounter opportunity. He pointed to the Pope's teaching on social justice, including the need to embrace the poverty in the Global South. Paul referred to the partnership with St. Jerome's University and the Diocese of Hamilton and possibly offering a future student experience, pending Board approval. SSVP Brant pointed to the possibility of twinning with the community in Guatemala (prayer, projects, work and charity).

Paul advised that the roll out of contemplative prayer in secondary schools has begun and discussed some of the challenges and opportunities of this work. During Lent, St. John's College will be introducing school-wide Christian Meditation at the beginning of each day over the announcements. Preparation and catechesis for students will happen prior to the practice. The diverse faith backgrounds in secondary schools presents a challenge, but Christian Meditation provides a favourable access point for meditation.

The System Faith Day will take place on October 13, 2017 hosted at Assumption College School. Bishop Miehm will be the celebrant at the closing Eucharistic celebration.

#### 4.3 Dioceses/Deaneries Updates

Father Alan shared a summary of Pope Francis' "Amoris Laetitia" (The Joy of Love) as directed by Bishop Fabbro, Diocese of London. Father Alan focused on the fact that children must be educated in sex and sexuality. The summary encourages the Church to be merciful, loving and accepting in the areas of marriage, sexuality and divorce.

#### 4.4 Society of St. Vincent de Paul Update

Pat Lenz advised that the SSVP will not be moving for now and that the project is financially stable. SSVP is using data to "drive instruction". Approximately \$100,000 in non-perishable food items have been distributed to clients. There has been a move towards a model where students work alongside volunteers in the store, as learned from the experience with our elementary Social Justice teams. Peter Giordano is heading up production of awareness promotional items, e.g., posters, brochures, etc., to be made available for distribution.

A second professional development session for our FSL teachers and the Special Education department is scheduled for April 4 and will include further training/discussion on topics such as autism, learning disabilities, writing Individual Education Plans (IEPs), as well as assessment and technology, which are areas of learning priorities identified by the FSL teachers.

#### 7. Presentations

#### 7.1 The role of Special Education Advisory Committee (SEAC)

SEAC Chairperson, Jill Esposto, provided the group with an overview of how she became involved with the Committee. Although she became involved as a Director of Services with Brant Family & Children Services, she is also a resident of Brantford and a parent to two grown children who attended our schools during their school years. Jill shared the importance of strong partnerships within the community in order to support and develop the unique potential of all students within the Board. The SEAC provides the opportunity to engage parents with the community to enhance the support for our learners with special needs and to promote quality education for all.

Carmen McDermid, Student Achievement Lead - Special Education, updated the group on the Working Together Symposium (WTS) that took place on Saturday, February 4, 2017 at Assumption College. This educational symposium is an example of a collaboration between System Board personnel (Special Education., Mental Health and Kindergarten), Grand Erie DSB and community agencies (some are represented on SEAC) to provide parents/guardians, educators, students and service providers of children, youth and individuals with special needs, behavioural and/or developmental issues, the opportunity to attend a variety of excellent workshops. The guest speaker was Dr. Jeff St. Pierre, Child and Parent Resource Institute, London, who shared insight on the risk and protective factors for children and youth mental health.

Another collaborative workshop between the Board and community agencies will occur on Saturday, March 25, 2017 at the Brant Haldimand Norfolk Parents as Partners workshop. This full day workshop is designed to support families with the transition as their child prepares for Kindergarten. Information and activities assist parents as they prepare for an effective partnership with their school team. The workshops are designed for parents/guardians who have a child diagnosed or exhibiting difficulties with one or more of the following: Autism Spectrum Disorder, physical disabilities, speech and/or language delays, behaviour concerns, developmental disabilities, anxiety and other concerns. The registration deadline is March 9, 2017.

Carmen shared how the Board, along with community agencies, plan entry to school case conferences in April for parents/guardians of children who have special needs who are entering our system in September 2017. The conferences assist with a more seamless and informed transition into school for our future Kindergarten students.

Carmen distributed and referenced pages 10-16 of the 2016-17 Special Education Plan, which outlines Special Education personnel within the Board and how these positions support student learning and the Board Strategic Plan. Carmen concluded that the Special Education team, along with the Student Support Services and Student Achievement Team, consistently work together to better meet the needs of all students.

#### 7.2 Parent Math Night Update

The Committee welcomed System Student Achievement Teacher Sue Defreyne who provided the group with a fun Box Car and One Eyed Jack game play as an introduction to the math update. Sue discussed new tools and approaches that are being used to teach math and how they are proving useful in helping students to understand number sense, to process math equations, and to be able to explain different thinking patterns. Sue addressed parent inquiries on having difficulties with assisting their children with their math homework, and noted helpful websites such as <a href="www.homeworkhelp.com">www.homeworkhelp.com</a> and Khan Academy. Sue highlighted an upcoming event at Jean Vanier School on May 9, 2017 that will focus on engaging students and their families with mathematics (Appendix A).

#### 8. Correspondence

Superintendent Shypula shared information regarding the Ministry of Education's Parent Involvement Committee (PIC) Symposium taking place in April 2017. This symposium is an effective way for parent members of the Regional Catholic Parent Involvement Committee and Catholic School Advisory Councils to network and collaborate with other parents and system leaders, and to create local strategies to enhance parent engagement in their communities while supporting student achievement and well-being.

#### 9. Reports and Committee Updates

#### 9.1 School Climate Survey

Superintendent Shypula provided an update on the School Climate Survey that parents, staff and students completed in 2016 and encouraged them to visit their school websites to access the follow-up action plan. An analysis of who participated in the survey and how principals collected their information was shared with the group.

#### 9.2 Parent Symposium Update

Information regarding the upcoming Parents Reaching Out (PRO) event titled, *Raising Responsible, Awesome Kids,* was shared. The event will take place on April 27, 2017 at Assumption College School starting at 6:00 pm. Guest speaker, Gary Direnfeld, MSW, RSW, will provide insight and share key strategies on raising awesome, responsible kids. Appetizers and light refreshments will be served by Assumption College students and complimentary childcare will be available. Various community agencies will be on site to provide information and to answer any questions that parents may have. Further information will be provided to schools, parents and various community agencies.

#### 9.3 Renewing Our Promise Initiative

The Bishops of Ontario, along with the Institute for Catholic Education (ICE) and the Office Provincial de l'Éducation de la foi Catholique de l'Ontario (OPECO) are inviting members of Catholic School Boards across Ontario to the "Renewing the Promise: Exploring the Critical Role of Catholic Education in Contemporary Society" Symposium being held in Toronto on November 14 and 15, 2017. This symposium responds to the need for Catholic education communities to engage in conversation to deepen understanding of both the challenges and opportunities Catholic schools face in our increasingly complex and secular society. Exploring the theme of "Renewing the Promise" will be an extension of the work done in the "This Moment of Promise" and "Fulfilling the Promise" documents.

The Symposium will bring together representatives of the key stakeholder groups who, together, share the responsibility for Catholic education. This face-to-face discussion will invite participants to discuss the following three questions:

- How do you see Catholic Education in Ontario supporting students to be living witnesses to their faith in Jesus Christ?

- What are some current opportunities presented in Catholic Education in Ontario?

Following the face-to face meeting and discussions, participants will then be encouraged to share individual responses to each question using the Thought Exchange on-line process. This comprehensive data will then serve as the basis for specific conversations that will take place when Board teams gather during the symposium in November.

#### RENEWING THE PROMISE

**Public Session** 

#### **BACKGROUND INFORMATION:**

Following the province's decision to extend full funding in support of Catholic schools, and their commitment to publically fund four school systems (French and English, Public and Catholic) the Bishops of Ontario recognized the need to gather the Catholic education community in conversation to understand both the challenges and opportunities that were present at that time. The Bishops also established the Institute for Catholic Education (ICE) and l'Office Provincial de l'Education de la foi Catholique en Ontario (OPECO) with a mandate to animate and encourage cooperation between the Catholic educational partners. From time to time, at the request of the Bishops, and with the encouragement and support of the partners, ICE and OPECO have arranged provincial symposia bringing together representatives from every sector of the Catholic education community to explore contemporary issues in Catholic education. The last provincial symposium was held in 2011.<sup>1</sup>

For an earlier generation of Catholic educators, documents developed by the Bishops of Ontario, "*This Moment of Promise*" and "*Fulfilling the Promise*" established a clear and compelling mission and vision for Catholic schools. Today, our mission and vision for Catholic education have not changed, but our context has changed profoundly. At this time, it is important that we come together in conversation, gathering as a community to name and understand the challenges presented by an increasingly complex and secular society today, and to identify and build consensus around the opportunities that will shape our future.<sup>1</sup>

#### **DEVELOPMENTS:**

#### **Symposium**

A district team will be invited to attend the upcoming province-wide symposium on Catholic Education. Focusing on the theme, "Renewing the Promise: Exploring the Critical Role of Catholic Education in Contemporary Society", the symposium will be held in partnership with the French Catholic education community in Toronto on November 14 and 15, 2017. This symposium, will help us better understand the ways in which Catholic schools serve and support the mission of the church, while bringing the gifts of justice, peace and joy to our students and our province alike.<sup>1</sup>

The Symposium will bring together representatives of the key stakeholder groups who together share the responsibility for Catholic education. The suggested local Board Team composition (14) includes:

#### **Pastoral Letter on Catholic Education**

For an earlier generation of Catholic educators, documents developed by the Bishops of Ontario, "*This Moment of Promise*" and "*Fulfilling the Promise*" established a clear and compelling mission and vision for Catholic schools. Today, our mission and vision for Catholic education have not changed, but our context has changed profoundly.<sup>2</sup>

Subsequently, the Bishops of Ontario will undertake to develop a pastoral letter, *Renewing the Promise*, which will reflect on the challenges and opportunities that accompany this moment in time for Catholic education in Ontario. This renewed vision of Catholic education in the province of Ontario will speak directly to those who share responsibility for Catholic education today, offering encouragement, guidance and support for our work in the coming years. The potential release date for the pastoral letter will be Catholic Education Week 2018.<sup>2</sup>

#### **Catholic Community Consultation**

In order to inform the content of the symposium and to assist the Bishops of Ontario in understanding the current context in our Catholic schools, ICE will be undertaking a community consultation prior to the symposium.

Through the independent facilitation of *Thoughtexchange*, a third-party software solution, ICE and OPECO will meaningfully engage all the partners in Catholic education and within the school board communities using an open process.<sup>2</sup>

Local school boards will have access to the data and will be welcome to use the data to help inform their future strategic planning process.
