#### 5. Committee and Staff Reports

#### 5.1 Science Technology Engineering Maths (STEM): Innovation Learning Plan Updates

Superintendent Telfer provided an overview of the STEM program and how it is being implemented in the classroom. STEM is currently operating in ten elementary schools with the intention to introduce the program to more schools in the near future. The program is helping students develop the skills and critical thinking required to adapt, create and succeed. Superintendent Telfer provided an update on developments such as the creation of lessons focusing on engineering and technology, the addition of a 0.33 STEM itinerant teacher and that each classroom, Kindergarten to Grade 8, will receive 1500 minutes of STEM Innovation Learning. She also noted that measurement, language and journaling are some of the areas that are used for assessment.

The STEM team presented a short video showcasing students and teachers active in the classroom utilizing STEM activities. The team also demonstrated some of the activities being used such as MicroBit, Make-Makey Banana Piano and a boat building challenge.

#### 1. Opening Prayer

#### 2. Introductions and Welcome

#### 5. Discussion Items

#### 5.1 Mental Health & Well-being Strategy 2017-20 and 2017-18 Action Plan

Dianne reviewed the updated *Mental Health & Well-being Strategy* with the committee and highlighted priorities for this school year. She noted 3 years ago, the original strategy included 'Addictions' in the title but has since been changed to reflect current trends in 'well-being'. Despite this change, addiction needs are still addressed within the strategy.

The group reviewed the 2017-18 *Action plan* and discussed if 'working groups' should continue in order to propel our work forward.

Based on previous membership and those present at today's meeting, the following working groups were established.

a) Mental Health Literacy: Kerri Chartrand, Pat Brophy, Connie McAllister,

b) Mental Health Promotion: Arden Smelser, Charmaine Hanley/Michael Pin,

Dianne indicated these working groups would be called upon on an as-needed basis in order to meet the goals of the Mental Health and Well-being strategy.

#### 5.2 Student Voice-Mentally Healthy Schools Competition

Dianne shared examples from other Boards as to how student voice has been engaged with regards to mental health and well-being in schools. The ideas included soliciting student voice through art, prose, poetry, song, video, etc. The committee liked the idea and thought there would be enough time to introduce the contest in the late fall/early winter and have submissions displayed during Catholic Education Week/Mental Health Week. An ad hoc group was created to work on this project and includes Gerry McLellan, Cindy Miller, Heidi Pasztor, Chandra Portelli and Dianne Wdowczyk. It was highly recommended Tracy Austin be either consulted or included in this working group.

**Action Item**: Dianne to call separate meeting to initiate planning process.

#### 5.3 Lost at School Book Study

Dianne indicated 250 copies of <u>Lost at School</u> by Ross Greene were purchased over the summer with the intent of sharing with staff across the board using a book study format. The book was highly recommended by a few administrators in our board, and Assumption College had requested 25 copies of this book back in the Spring of 2017 with the intention of their well-being team to read over the summer. Pat Brophy indicated their team would be meeting shortly to begin to reflect on their learning. Dianne had reached out to St. John's College and Holy Trinity and administrators from both schools indicated they too would like 25 copies of the book and to engage in a reflective process. Copies of the book were distributed to committee members.

Michelle Shypula indicated she would look into any current books administrators are reading to see if there is a place to offer Lost at School to administrators.

#### 6. Information Items

#### 6.1 Literacy and Mental Health

Melissa Connelly was unable to attend today's meeting so Dianne spoke to the *Mindfulness working group* Melissa began in the spring of last year. The working group was charged with reviewing and working through a number of resources over the summer that link mindfulness practices with increased literacy. The group will be meeting for the first time at the end of the month where they will share their experiences, dive deeper into the understanding of the neuroscience behind mindfulness and literacy learning, do some hands-on activities, plan some lessons to bring back to classrooms, and discuss next steps.

#### 6.2 Triple P Programming and psycho educational information.

Diane indicated Triple P (Positive Parenting Program) is being endorsed and facilitated by the Brant County Health Unit in Brant and Brant County. In addition to the traditional 8 week groups that have been offered in the past, the health unit is now offering seminars which are typically under 2 hours in duration and are delivered in schools. More popular topics include: The Power of Positive Parenting, Raising Confident Competent Children, and Raising Resilient Children. Notre Dame, Brant, Holy Cross, St. Basil and St. Pius have hosted seminars to date.

Triple P also provides psycho educational materials in print format and the health unit has offered to share these with schools as part of their newsletters. As engaging parents, and sharing more information regarding children's mental health is a priority in the new Mental Health & Well-being strategy, Dianne indicated she vetted and recommended to Tracy Austin, approval of the Triple P content to be shared via the health unit.

It was questioned as to whether the Haldimand Norfolk Health Unit also offers Tripe P. Dianne indicated that at this time, they did not. Dianne noted she understood the Brantford sessions are not exclusive to residents of Brant so if people were willing to travel, they would be accepted. **Update**: Dianne has since connected with the manager of the BCHU Christina Rajsic who indicated the BCHU can be flexible and could possibly deliver seminar's in our Haldimand Norfolk Schools if requested.

# 6.3 Establishing Working Relationships with Third Party Professional or Paraprofessional Service Providers: Update

Dianne and Michelle reminded the group this was an Administrative Procedure resulting from P/PM 149 and was adopted in April 2017. Dianne indicated that several agencies were contacted over the summer and asked to complete formal partnership agreements which would be reviewed annually. The committee had some questions about *Appendix B-Parental/Guardian Consent to Access Community Partner Services within Brant Haldimand Norfolk Catholic District School Board* and wondered specifically about the last section which addresses 'when' the student may participate in services.

**Action item**: Dianne and Michelle to seek clarification from Leslie Telfer as the AP at the time of creation was under her portfolio.

#### 6.4 Violent Risk Threat Assessment Community Protocol Update

Dianne indicated that she understood Kevin Cameron is in the process up revising his work, possibly resulting in a complete overhaul of the current Threat Assessment Community Protocol likely in the Spring. Steps have already been taken between the GEDSB and our Board to revise the current protocol to reflect our Board's involvement. Dianne indicated that if we wish, the Grand Erie board is open to co-hosting a protocol signing in the late fall to formally reflect our boards commitment to Violent Risk Threat Assessment at a community level.

Dianne also indicated GEDSB is hosting Kevin Cameron on October 31-November 1st. The topic is family assessment, and spots are available for non GEDSB members to participate. The committee expressed a great deal of interest in this topic. Dianne is waiting for confirmation as to how many spots would be available to our board and will also attempt to secure Kevin Cameron for the 2018-19 school year.

#### 6.5 Student Support Services Update

Dianne indicated Student Support Services has expanded by 2 Child and Youth Counsellors and now boasts a compliment of 3 Social Workers and 5 Child and Youth Workers in total. With the addition of the new CYW's, school location assignments were revised with the hopes of creating a balanced case load where the CYW would more present and available to each of their elementary schools.

#### 6. Community Agency Updates

Teresa Westergaard-Hager- Supervisor - Community Outreach, Norfolk Association for Community Living

The organization participated in several training opportunities as well as many social events such as, picnics and baseball tournaments, hosted by various agencies in an effort to continue to engage families through the summer months. The agency continues to focus on promoting and supporting the inclusion of people with developmental disabilities throughout the province and Canada. Norfolk Association for Community Living is working towards supporting individual needs rather than running programs and the agency is working with individuals and family members to ensure everyone is on board and dispel any fears that come with change.

Catherine Custodio- Child Welfare Supervisor, Children's Aid Society of Haldimand & Norfolk

The Children's Aid Society of Haldimand and Norfolk held a 5K Walk on Saturday, September 16 to raise awareness in the community and to raise funds to help local children attend camp or recreational activities (*Little Dreams*) and youth attend post-secondary school (*Big Dreams*). They surpassed their goal by raising \$6,529 and Scotiabank generously matched their funds by contributing another \$5,000, which brought the grand total to over \$11,500. The agency, working with a Crown Ward Education Council for the past 9 years, identifies youth at risk and focuses on youth who are not graduating from high school. Funds received by the Ministry are being used towards helping to support these youth by trying to improve the number of students graduating. Catherine shared that a member of their team is from the Hamilton District School Board. This individual recently retired and will be the new facilitator and event planner for their organization. Catherine is open to ideas from the group that will lead to increased graduation rates.

Christine Pearce- Program Manager, Woodview Mental Health & Autism Services

Camp Unity is a specialized summer day camp experience addressing the unique needs of children and youth ages 6 to 18 who have Fetal Alcohol Spectrum Disorder. The camp was very well received this year and Woodview held a Summer Celebration on Tuesday, September 19 at Mohawk Park in Brantford to celebrate the students and their successes. Woodview also provided Summer Programming through Wrap Around for Complex Needs, as well as through the Intensive Child & Family Services Program. There were over 40 children in attendance who they serviced to help meet their goals of emotional regulation, social skills and team building.

The Respite program is now operational from Monday to Thursday in the evening, designated Fridays and Saturdays and on all Professional Activity Days. Members who have knowledge of children age 4 to 18 years in need of this service were encouraged to connect with Contact Brant.

On Thursday September 28 all families connected to Woodview were invited to Brantwood Farms from 5 to 7 p.m. for a family picnic. Collaborating with Six Nations and Brantford zones, Woodview has implemented the SNAP (Stop Now and Plan) model, which runs two programs per week from 4 to 8 p.m. Additionally, they are implementing the Zones of Regulation which is also being used in the Board. Woodview's new initiative is looking at services and offering them where the students are, which is often in schools. This will assist those who may not be able to get to the agency offices for services and yet still be able to offer them counselling etc. They will potentially be looking at three additional areas for counselling and services for families with children ages 0 to 18. Woodview is also looking at a new Early Years initiative where they are collaborating with community centres and hubs in order to provide additional support for parents.

#### 7. Correspondence

On behalf of Jill Esposto, Superintendent Shypula shared that October is National Child Abuse Prevention Awareness Month and Tuesday, October 24 is "Dress Purple" day. The agency is looking to collaborate with our Board again this year and to tie in to our Board theme: Act Justly, Love Tenderly, WALK HUMBLY with your God (Micah 6:8). In collaboration, they are developing communication to share with our school administrators including suggested activities for students. This year the School Board and agencies are collaborating to set up VIP POD visits within Brantford and Brant County schools (Holy Cross and Sacred Heart, Paris) to promote the campaign within our schools and communities.

The Ministry distributed a Memorandum to Directors of Education on September 1, 2017 regarding updates and next steps on Integrated Delivery of Rehabilitation Services (IR), a key initiative under Ontario's Special Needs Strategy (SNS). In the memorandum, the Ministry wanted to take the opportunity to "thank the Steering Committees for their work over the past two years developing integrated rehabilitation service delivery models. Steering committees have identified a number of challenges and have asked for support in the form of provincial direction and policy development. Given the complexity of the transformation to create seamless delivery of Integrated Rehabilitation Services and our commitment to ensure seamless support for families, the ministries will be taking a measured and phased approach to policy development and implementation. The ministries will establish a provincial advisory group that will include clinical experts, sector partners and education stakeholders to provide advice to the ministries on key issues including: the rehabilitation components of **Policy** Program Memorandum (PPM) 81: Provision of Health Support Services in School Settings, implementation of rehabilitation services across education and community-based sectors in a tiered service delivery model, the use of technology for information sharing and reporting, funding and accountability measures. Details about this provincial advisory group will shortly follow and at this time, steering committees should cease final proposal developments."

#### 8. Reports

#### 8.1 Student Achievement Leader: Special Education

On Friday, September 15, 2017 the Special Education Department hosted their first Professional Development Day for those Educational Assistants (EA) requiring certification in either Nonviolent Crisis Intervention (NVCI) (25 participants) or First Aid (17 participants). The NVCI certification requirements changed last June to include a more comprehensive 1.5-day training which also includes a focus on autism. Training continues to reinforce that ONLY two out of the 10 units focus on physical intervention while the other eight units focus on communication, verbal intervention, decision making, etc. The goal is to have all EAs receive the new 1.5-day certification by the end of 2018. Feedback to date has been extremely positive. All principals will receive NVCI training on November 3 (full day) and December 15 (afternoon only). There are two new Board NVCI trainers: Crystal Donohue (ABA Lead) and Dianne Wdowczyk-Meade (Mental Health Lead) with the hopes of certifying one additional trainer.

First Aid certification continues to reinforce safety for students and staff. Re-certification occurs every three years as regulated by Red Cross.

The Special Education Services team have identified key areas of focus for the 2017-18 school year including best practices/teaching strategies for students with a learning disability. The department purchased and distributed to each school a new Hawthorne manual titled, 'Learning Disability: Intervention Manual'. Special Education Resource Teachers (SERTs) received a brief overview of the book and were asked to share this resource with staff. The manual will be shared with Administrators at a Family of Schools Meeting. Future Community of Practice agendas will have an LD, Math and self-regulation focus.

As part of a special project initiative started last year, a number of Snoezelen resources (bubble tubes, nests, sensory kits, etc.) were distributed to 15 more schools (12 elementary and 3 secondary schools). Additional support will be provided to the remaining nine schools before the year-end. Schools were to identify the most appropriate place to create a calm, learning space utilizing these resources. System staff are available to assist schools with choosing the best location, setting up the space and addressing staff in regards to the purpose of these items.

Additionally, based on feedback from school SERTs, other items purchased for schools included: theraputty, breathing balls, fidgets, chew sticks, weighted stuffed animals, rain sticks, timers, beanbag chair, tent and wiggle cushions. All of these items were purchased to support all learners, not just students with special needs.

#### New SERT Training:

There are 11 new SERTs joining the Special Education Department this year. The department has experienced a significant change in personnel due to retirements, maternity leave, teachers returning to the classroom and as a result additional Ministry funding allocated to staffing school resource teachers. A new SERT mentorship/training program has been established which will provide four full release days for new SERTs where they are partnered up with System SERTs to receive training on key topics such as writing effective IEPs, Woodcock Johnson IV Achievement Testing training, team meetings, review of SERT checklists, preparing high needs packages, appropriate referrals etc.

#### 8.2 Superintendent of Education

Superintendent Shypula introduced the Board Student Achievement Lead, Kerri Chartrand, whom, in her second year in the role, was excited to share with our community agencies updates on our Math and Literacy strategies for the upcoming School Year. Kerri provided an overview of the Differentiated System Support Plan for Student Achievement for 2017-18 (See Appendix A). The plan was created in response to student learning needs using historical data. The plan includes the various support from Superintendents, System Teachers, Math Leads, Early Childhood Educators (ECEs) and SERTs.

#### Ontario's Renewed Early Years and Child Care Policy Framework

Public Session

#### **BACKGROUND INFORMATION:**

Ontario's Early Years and Child Care Policy Framework was introduced in 2013. The framework shared the vision for the Early Years in Ontario and included the province-wide introduction of full-day kindergarten. Supplemental to the framework, on August 31, 2015, the Child Care and Early Years Act, 2014 (CCEYA) came into effect, replacing the Day Nurseries Act (DNA). After ongoing review, the government released the Renewed Early Years and Child Care Policy Framework in June, 2017. This Renewed Early Years and Child Care Policy Framework contains a comprehensive set of initiatives that make high-quality early years experiences possible for even more children and families. The framework reinforces the government's commitment to help 100,000 more children, from birth to age 4, access licensed care. The framework sets a renewed vision and seven key priority areas of action, including:

- 1) Increasing access to early years and child care programs and services
- 2) Ensuring a more affordable early years and licensed child care system
- 3) Establishing an Early Years Workforce Strategy
- 4) Determining a provincial definition of quality in the early years
- 5) Developing an approach to inclusion in early years and child care settings
- 6) Creating an outcomes and measurement strategy
- 7) Increasing public awareness of Ontario's early years and child care system

Ontario's renewed framework will work to support a higher quality, more responsive and affordable early years and child care system.

#### **DEVELOPMENTS:**

School boards are a key partner in supporting the Early Years vision and have a shared responsibility for its implementation. The comprehensive scope of the legislative framework for the child care and early years sector has required the ministry to take a multi-year, phased approach to implementation Updates in the following focus areas indicate the status of implementation for the board.

Build on the successful implementation of FDK, continue to work with partners to lead the roll-out of the expanded duty to ensure the provision of before-and-after school programs for children 6-12 year olds, where there is sufficient demand.

We have before and After Programs operating in 25 of our 28 elementary schools. Before and After Care programs are offered by multiple third party providers.

The YMCA Hamilton/Burlington/Brantford is the main provider and services 13 of our 25 schools.

Support differentiated professional learning opportunities to deepen understandings of the program pedagogy and expectations outlined in *The Kindergarten Program* (2016) and *Growing Success: The Kindergarten Addendum* (2016) and the implementation of the Communication of Learning templates.

All kindergarten teams have received training and completed Communication of Learning reports in February and June of 2017.

Support the joint planning of capital funding projects related to child care and child and family centres in schools with school board staff and service system managers from Brant and Haldimand Norfolk counties.

The board has made a joint submission for Capital Funding for Child Care and Family Programs to renovate space at Holy Trinity School in Simcoe and Our Lady of Providence School in Brantford. Ministry approval of the proposal is pending.

Engage with and support joint decision-making alongside consolidated municipal service managers (CMSMs) and/or district social services administration boards (DSSABs), child care operators, community partners and families to ensure coordination, collaboration and support of a system of responsive, high-quality, accessible, and increasingly integrated early years programs.

We continue to work with our partners on the development of integrated Ontario Early Years Child and family Centres (OEFCYCs). A proposal has been prepared that enhances, relocates and reconfigures OEFCYC programs and services to meet community needs. Changes to existing centres, including Parent and Family Literacy Centres(PFLCs) will not occur until the fall of 2018.

Oversee the implementation of the Early Development Instrument (EDI) including the collection of Cycle 5 EDI data in the 2017-18 school year and associated knowledge mobilization within the community.

All teachers new to Kindergarten will receive training on using the EDI data collection tool. All kindergarten teachers will complete EDI assessments prior to March 31, 2017.

Support the EYE@K Early Years Experiences Collection at Kindergarten Registration Reporting Initiative 2017-18.

Steps are in place to support the EYE@K 2018-19 kindergarten registration process. Parents/guardians will have the opportunity to register their junior or senior kindergarten-aged children in our schools using an online tool.

The registration process will include the opportunity to complete the voluntary survey that the Ministry has developed to collect information about how children in Ontario participate in childcare and early years programs prior to transitioning into kindergarten.

#### PRIMARY AND JUNIOR/INTERMEDIATE CLASS SIZES

**Public Session** 

#### **BACKGROUND INFORMATION:**

The government began its program to reduce Primary Class Size (PCS) in 2004-05. The targets that have been established are that 90% of Primary classes contain 20 or fewer students and 100% of Primary classes (including grade ¾ combined classes) contain 23 students or less. The class size regulation will continue to require an average FDK class size of no greater than 26, but will now also require that at least 90% of FDK classes have 30 or fewer students.

#### **DEVELOPMENTS:**

#### **Primary Class Size**

School boards were asked to submit their initial 2017-18 plans to meet the PCS target in July 2017. Our Board was able to meet the target of 90% of Primary classes at 20 or fewer pupils based on projected enrolments. In September 2017, staff reviewed the actual elementary pupil enrollment and school organizations and it was necessary to add a primary class to maintain board compliance. A FDK class was also added.

#### Junior/Intermediate Class Size

Beginning September 1, 2012, Ontario Regulation 132/12 amended class sizes for Grades 4 to 8. O. Reg. 132/12, s. 7 specifies in the embedded table that the average class size for classes in Grades 4 to 8 within the Brant Haldimand Norfolk Catholic District School Board not exceed 25.60 students. Changes to the regulation were announced in the Spring of 2017.

For 2017-18, any board with a regulated Grade 4-8 class size average maximum exceeding 24.5 is required to reduce this average to 24.5 within five years. The class size regulation will be amended each year until the Board reaches a maximum average class size of 24.5. For the 2017-2018 school year our class size regulation is 25.24. In order to meet this requirement, 3 additional Junior/Intermediate classes were added in September. The actual average class size for Grades 4 to 8 within our Board is 25.11 students.

#### **RECOMMENDATION:**

#### INTEGRATED ACCESSIBILITY PLAN ANNUAL REPORT 2016-17

Public Session

#### **BACKGROUND INFORMATION:**

#### Introduction

On December 14, 2001, the *Ontarians with Disabilities Act, 2001* (ODA) was passed to improve access and opportunities for people with disabilities. The *Act* provides for the involvement of those with disabilities in the identification, removal and prevention of barriers so they can fully take part in the life of the province. *ODA 2001* was followed with the passing of the *Accessibility for Ontarians with Disabilities Act* (AODA) in 2005 and the standards within the *Act* pertaining to school boards are being disseminated.

The Integrated Accessibility Standards Regulation (Ont. Reg. 191/11), which includes Information and Communications, Employment and Transportation standards became law in June 2011. Public sector organizations were required to comply with these standards by January, 2014. On January 1, 2013 the Integrated Accessibility Standards regulation was amended to include accessibility requirements for the Design of Public Spaces with compliance expected by January 1, 2016.

The AODA applies to all public sector institutions including cities, municipalities, hospitals, school boards, colleges and universities, public transportation providers, and government ministries and agencies. Measures under the Accessibility for Ontarians with Disabilities Act require public sector institutions to develop, implement and enforce accessibility standards with the aim of achieving accessibility for persons with disabilities with respect to goods, services, information, accommodation, facilities, employment, buildings structure and premises in the whole province by 2025.

#### **DEVELOPMENTS:**

The Brant Haldimand Norfolk Catholic District School Board Accessibility Committee on an annual basis:

- conducts research on barriers to people with disabilities in all facilities and reviews regulations, policies and programs, practices and services offered by the District;
- identifies barriers to be addressed, removed or prevented; and
- communicates its work to the Board of Trustees and to public stakeholders.

#### The Committee strives for the:

- continual improvement of access to school premises, facilities and services for all persons regardless of ability;
- participation of people regardless of their ability, and acts as their advocates in the development and review of its annual accessibility plans; and
- provision of services to all students, employees, parents of students and members of the community with disabilities.

The following were objectives outlined in year 2016-17 of the plan. The final column in the below chart indicates progress to date in each area.

Following review of the Accessibility Compliance report filed in December 31, 2015, the Board was in compliance with the Integrated Accessibility Standards Regulation of the AODA. The next date to file an Accessibility Compliance report is December 31, 2017. Additionally, the Board is approaching the end of year 5 of the Integrated Accessibility Plan. A next step will be to review and update the plan in consultation with the Accessibility Planning Committee, Special Education Advisory Committee (SEAC) and persons with disabilities to identify any required revisions and next steps to ensure compliance with the AODA as we progress to the 2025 achievement date.
