5.3 Strategic Plan – Vision 2020

Director Roehrig presented a plan to begin developing the next multi-year strategic plan. The 2015-2018 Strategic Plan will be concluding in June 2018. The Board will also be welcoming a new multi-year spiritual theme at the same time as the launch of the new strategic plan. He advised that conversations will be starting soon to implement a plan in order to have information available to the Board after the elections. The Catholic Education Advisory Committee is currently working on gathering information in anticipation of presenting a spiritual theme in the spring.

5.4 Graduation Rates

Superintendent Daly advised that the Ministry of Education will be releasing the 2016-17 graduation rates in the spring. He presented the preliminary results for the provincial calculation of students starting their Grade 9 education with our Board which were: 83% (4 year) and 87% (5 year) graduation rates. He also reviewed the Board's internal calculation to measure the cohort of students who begin their Grade 9 education with our Board and graduate with our Board which were: 90% (4 year) and 91% (5 year) graduation rates.

She highlighted work being done to improve policies and procedures, the development of an online training tool for bullying and creation of a school code of conduct template. The District Safe and Accepting Schools Committee is currently reviewing the district plan. Superintendent Shypula also provided an overview of the following goals captured under the Safe and Accepting Schools pillar of the strategic plan:

- Enhance inclusive school environments that support positive mental health.
- Improve policies and procedures to have an impact on safety in schools and improve training for students, staff and leaders in the area of safe and accepting schools.
- Improve the communication of initiatives and supports that are in place to ensure student safety.

Carmen McDermid led the group in the opening prayer.

2. Welcome and Opening Comments

Superintendent Shypula welcomed the group and Paul Sanderson (Acting Chair) led a round of introductions for the benefit of Peter Svec and SEAC members in attendance.

3. Approval of Agenda

5. Correspondence

Superintendent Shypula provided an overview of a letter sent to the Ministry of Education by the Grand Erie District School Board (GEDSB) to SEAC Committee members (see Appendix A). The letter discusses the pilot project as set out in a memorandum by the Ministry on October 25, 2017, on plans to improve school-based supports for students with Autism Spectrum Disorder (ASD). GEDSB, who was not one of the 18 school boards selected for the pilot project, is asking the Ministry to consider allowing their Educational Assistants (EAs) to access the 40 hours of online training provided in the pilot project. SEAC members unanimously decided to not submit a letter at this time until we receive additional information from the Ministry about the pilot project.

6. Presentation

6.1 Sonflower Stables Experiential Trip

Peter Svec, *Student Achievement Consultant: Pathways*, shared an overview of his position with the Board, which encompasses providing experiential learning opportunities to students across the district. A few of the learning experiences provided to students were working at the local Food Bank, cleaning, feeding and caring for animals at the Twin Valley Zoo and most



recently the SonFlower Stables. SonFlower Stables provided a meditation component and activities for students that help build confidence and motivate them to participate. Peter shared a video of students reflecting on their experiences working at SonFlower Stables where they described what they enjoyed about this opportunity, their favourite memories and what they learned from their trip. The eight-minute video demonstrated some students retelling their experiences while others communicated their stories using written signs. Teachers and Educational Assistants (EAs) also shared their experiences in the video, describing the learning and emotional connection SonFlower Stables provided to students. Peter shared the students' excitement and contentment while learning through these opportunities.

7. Community Agency Updates

Jennifer Chapman- Child Welfare Supervisor- Haldimand-Norfolk Children's Aid Society

Jennifer shared how agencies are experiencing learning curves from the new legislation, which has now come in to effect in January 2018. Youth aged 16 to 17 years of age can volunteer to go into care with Children's Aid Societies and Haldimand-Norfolk Children's Aid Society has already received three in the month of January. The agency continues to look at staffing within their organization to ensure needs are being met and will be developing presentations, which will be offered within the communities at a later date. The legislation is not yet proclaimed.

Bonnie McKinnon- Trustee Representative

Bonnie shared that she attended the 2018 Ontario Catholic School Trustees' Association (OCSTA) Seminar where the Hon. Indira Naidoo-Harris made her first public address on January 19, 2018. The newly appointed Minister of Education spoke to the political panel: "Ontario's Education Priorities".

8. Reports

8.1 Student Achievement Leader: Special Education

Carmen provided updates regarding the January 22, 2018 Elementary Professional Development Day where an additional 32 Educational Assistants (EAs) received the new Enhanced Nonviolent Crisis Intervention (NVCI) training. To date, approximately 75 Educational Assistants have now completed the Enhanced training within our Board, which is on track with having all EAs trained by December 2018. Carmen shared information on many of the workshops that were provided such as *Boardmaker training*, which is a software tool used for making visual schedules and was a workshop offered in both the morning and afternoon. The Regulate to Educate workshop assisted educators in providing calming techniques/strategies so that they are better equipped to assist students with self-regulation needs. Math workshop were provided where the focus was on various math activities (Box Cars) that educators can use with their students including dice, cards, other manipulatives, etc. The Information Technology workshops demonstrated how to research information on educational sites to further enhance the students they are supporting. Educators were given an opportunity to explore all materials purchased for the EA Lending Library and to receive instruction on various tools that might work well with the students they are supporting. EAs were able to sign out items to take back to their classrooms to use with students.

Carmen spoke about the positive impact the Grade 2 Reconciliation Retreat has had in supporting our students before they receive the Sacrament at the church. The Retreat took



place on Wednesday, January 17, 2018 with five schools having students attend who would benefit from a more personalized teaching and stronger understanding of Reconciliation.

Carmen shared that on December 15, 2017, 33 principals and on January 12, 2018, 32 SERTs and Special Education Department Heads completed the new Enhanced NVCI training. It is the hope that this training will be instrumental in assisting principals, teachers and other educators in helping to de-escalate students before the need to physically intervene occurs. Should there be a need to physically intervene, the training outlines when it would be absolutely necessary and how to do this safely when students or staff are involved.

8.2 Superintendent of Education

Superintendent Shypula provided an update on the Joint Protocol for Student Achievement (JPSA). Introduced in 2015, the protocol is a joint information sharing process between the Children's Aid Societies, school boards and schools. Research indicates that student achievement in children and youth in care is significantly lower than that of the general school population. According to the Ontario Association of Children's Aid Societies (OACAS), in 2012-13, only 46% of Ontario's Crown Wards graduated from high school, compared to the overall rate of 83%. These statistics resulted in the Ministry of Children and Youth Services (MCYS) and the Ministry of Education making a commitment to improving educational outcomes of children and youth in care of or receiving services from children's aid societies. The protocol intends to facilitate that collaboration between the partnerships to enable students in care from Kindergarten to Grade 12 (e.g. Crown Wards, society wards) or who are receiving voluntary or court ordered services from CAS. The JPSA will contain administrative processes to support a student transitioning into or out of school. The planning for student achievement will include establishing a REACH (Realizing Educational Achievement of Children/Youth) Team to support and promote the educational achievement of the student and the development of an individualized ESP (Education Success Plan). The protocol will detail the dispute resolution processes between CAS agencies and school boards, including timelines for dispute resolution before escalation. Partners of the JPSA are as follows:

It is anticipated that the JPSA will be ready for official implementation in September 2018. Effective monitoring and evaluation of the protocol will include a formal review every two years.



9. Closing Remarks/ Adjournment

The meeting adjourned at 11:15 am and Superintendent Shypula thanked Paul Sanderson for chairing the meeting.

Also, we would be very interested to see a report on the success of the pilot as it relates to increased student achievement.

SCHOOL YEAR CALENDAR 2018-19

Public Session

BACKGROUND INFORMATION:

On December 5, 2017, boards received the revised Policy/Program Memorandum No. 151 (P/PM No. 151) regarding Regulation 304, "School Year Calendar, Professional Activity Days". This Policy/Program Memorandum replaces P/PM No. 151 released in December 9, 2011. Policy/Program No. 151 sets out the conditions governing and establishing school year calendars and outlines the following criteria that must be met:

- school year commences on or after September 1 and ends on or before June 30;
- the minimum number of school days required is 194;
- the minimum number of instructional days is 187;
- school boards must dedicate three PA days per school year to provincial education priorities and may dedicate up to four additional PA days per school year; and
- a board may designate up to ten instructional days as examination days.

Professional activities for the three mandatory PA days must be focused on teacher's professional learning with respect to the following current provincial education priorities, which are outlined in *Achieving Excellence*:

- Achieving Excellence
- Ensuring Equity
- Promoting Well-Being
- Ensuring Public Confidence

Calendar specifications:

- The school year has been set at 194 days.
- All calendars designate seven Professional Activity days (three designated as Ministry days; four designated as Board days). Of the seven days, five are shared.
- For the three Ministry-designated days, elementary and secondary calendars will share the same PA days (October 19, 2018, November 16, 2018 and April 12, 2019).
- The elementary calendar includes two PA days for report card writing (January 21, 2019 and June 7, 2019).

DEVELOPMENTS:

A School Year Calendar Committee meeting was held on January 19, 2017. The draft calendar was vetted by representatives from the Curriculum and Special Education departments, OECTA, OSSTF – Educational Support Staff/Early Childhood Educators/Plant Support Staff, the BHN Catholic Principals' Council, Senior Administration, Board trustees and Regional Catholic Parent Involvement Committee executive. As has been past practice, the proposed calendars were developed over the course of several meetings with representatives from the Grand Erie District School Board to maximize efficiencies in transportation.

Attached are the proposed 2018-19 calendars for elementary and secondary schools.

RECOMMENDATION:

STUDENT SUCCESS UPDATE

Public Session

BACKGROUND INFORMATION:

In 2003, the Ministry of Education introduced the first component of a *Student Success Strategy* in response to low graduation rates within the province (68%) and a corresponding high dropout rate. The goal of the strategy encompassing grade 7 to 12, was to:

- 1. Increase the graduation rate and decrease the dropout rate;
- 2. Support a good outcome for all students;
- 3. Provide student with new and relevant learning opportunities;
- 4. Build on students' strengths and interests; and
- 5. Provide students with an effective elementary to secondary school transition

DEVELOPMENTS:

Since then Boards have been directed to create Student Success Teacher positions and Student Success Teams in each secondary school and implement a variety of learning opportunities to improve the success rate of students in Ontario schools.

The Student Success Teacher and Student Success Teams

Student Success Teachers (SSTs) play a critical role in knowing the students who are identified as in risk. They, along with the other members of the school's Student Success Team, are tasked with knowing, understanding, and documenting all the factors that may either contribute to or limit the success of any in risk student. Student Success teachers mentor and advocate on behalf of students, coordinate and support the implementation of interventions and promote and monitor successful transitions and wellbeing.

Transitions

SSTs meet with the grade 8 teachers from their feeder schools to facilitate discussions around students in-risk. Guidance counsellors and the SERT may also be in attendance at the meetings. The purpose is to share information which will be helpful for programming and early prevention strategies.

The Student Success team in each secondary school is responsible for the implementation of strategies that promote a smooth transition from Grade 8 to Grade 9 for students who may struggle with the secondary school program. The requirement to support students through transitions is set out in policy. These strategies include the following:

 Developing a process for sharing student information between elementary and secondary schools, subject to rules relating to privacy and disclosure;

- Creating student profiles that highlight each student's strengths and interests, as well as the student's learning, social, and emotional needs;
- Providing assistance during orientation and other pre-entry activities;
- Providing individualized timetabling and putting in place appropriate support strategies and interventions, based on student strengths and needs, that will be sustained beyond the orientation period;
- Identifying advocates and mentors for students requiring additional support;
- Ensuring ongoing tracking and monitoring of student progress by the Student Success team.

Beyond the requirements outlined in policy, the Student Success Team can also support a smooth transition between elementary and secondary school by:

- Providing opportunities for Grade 8 students to visit the high school in order to explore the building, interact with high school students, engage in curricular and extra-curricular activities, meet teachers, administrators, social workers;
- Planning Grade 9 Information Nights for parents/guardians and Grade 8 students (before option sheet time);
- Facilitating alternate programming such as Ready, Set, Go and summer school reach ahead opportunities
- Engaging in cross-panel professional learning designed to improve the academic transition from elementary to secondary school. (e.g. gap closing in literacy and/or mathematics);
- Sharing information about incoming Grade 9 in risk students with their teachers early in each semester.
- Meeting (in the first few weeks) with Grade 9 students who are identified as in risk to assess how they have adjusted to high school

Academic Interventions and Support

SSTs support students in accessing additional academic supports to either prevent an unsuccessful outcome or to regain the credit after an unsuccessful outcome. This could include connecting students with lunch time or after school academic support or accessing credit rescue or credit recovery opportunities.

Learning Opportunities

Varied learning opportunities have been developed in the hopes that they might significantly change a student's attitude toward school and create a positive school experience.

Dual Credits

Students have the opportunity to earn credits that count towards their high school diploma and college diploma or apprenticeship certification.

Cooperative Education

A flexible program that combines classroom and workplace learning.

Ontario Youth Apprenticeship Program (OYAP)

By participating in OYAP students gain on-the-job training and experience in an apprenticeship in a skilled trade while earning credits towards the Ontario Secondary School Diploma (OSSD). Students accumulate workplace hours that count towards both secondary school co-op credits and the requirements of an apprenticeship program.

School-Within-a-College (SWAC)

Secondary school courses are taught by secondary school teachers, and college dual credit courses are taught by college professors or instructors, within a collaborative learning community on a college campus.

Specialist High Skills Major (SHSM)

Bundles of 8-10 credits that allow students to focus their learning on a specific economic sector while getting their high school diploma.

Supervised Alternative Learning (SAL)

Intended to be used for a very small segment of the student population, when other measures to help a young person remain in school are not effective. A period of time away from regular school attendance can help a young person resolve an issue so that he or she can return to school later.

To promote success in school and in life, it is essential for our schools to provide opportunities and support for all students to plan their individual pathways through school in order for each to make a successful transition to his or her initial post secondary destination.

RECOMMENDATION:
