6. Update on April RCPIC Meeting

4. Information and Discussion Items

4.1 Give the Best of Yourself

Keri Calvesbert shared about the launch of the new initiative, "Give the Best of Yourself" in our school district. The initiative connects to the Belonging and Wellness strategic priorities of our MYSP "for all", focusing on character development and faith formation for students and staff in our school communities through the intersection of sport and faith. To support our staff, educators and coaches, a 5-part Virtual Speaker Series began in March and will run through June. Each evening session is 1-hour in length and introduces the core values of the initiative: Encounter, Formation, Witness and Proclaiming Joy. In April, in our Secondary schools, Student Athlete Wellness Kits will be distributed to all students. In April – June, Secondary students will have opportunities to participate in a Virtual Speaker series taking place during the school day. Weekly workouts and reflections will be sent out via school social media to compliment the Wellness Kits. In May, Grade 8 students will participate in a Virtual session and receive Student Athlete Wellness Kits.

4.2 New Board Spiritual Theme - Update

Keri Calvesbert explained that moving forward, it is the desire of the district to align our Board Spiritual Theme on an annual basis with the OCSTA Catholic Education Week theme. OCSTA has advised that we will have the CEW 2022 theme in early June 2021. This timing will allow for district planning to support faith formation and spiritual development for the following school year.

4.3 St. Vincent de Paul Update

Pat Lenz reported on various Conference activities and store operations since the shutdown on December 26th due to COVID-19. During the shutdown, Brant SSVP was able to maintain response to phone calls for emergency assistance and full voucher distribution as of March 2021. The store has re-opened for donations, shopping, pick-up, and delivery. The Conference is working with limited human resources. Peter Giordano spoke to the partnership between our school district and Brant SSVP that continues to thrive. A total of \$3440.00 was donated from

BHNCDSB during Advent. School Lenten campaigns are currently underway through SchoolCashOnline to support the three priority areas as outlined: Food hampers and grocery store gift cards, bedding sets, and beds for the Bed for Every Child Program. Pat Lenz shared about how during this time of pandemic, they have received grants from United Way to be able to sustain personal hygiene item supplies and beds for their bed campaign.

4.3.1 Board Lent Outreach and Visit to Brant SSVP

Lorrie Temple noted that our schools are supporting SSVP priorities (both Brant and Norfolk) using SchoolCashOnline donations this year. Lorrie shared about her experience of visiting and touring the Brantford store and the wonderful partnership that has been established between the Board and SSVP. Following this visit, Lorrie arranged for excess furniture from the CEC to be donated to the store.

4.5 Catholic Education Week (CEW) 2021

Keri Calvesbert briefly highlighted some planned events for the 2021 CEW, "Nurturing Hope" (May 2-7, 2021). On Monday, May 3rd, a 1-hour virtual event is being held to recognize our Catholic Student Leadership Award winners. Secondary schools will be sharing Transform Alumni videos (posted on the Board website). Bishop Crosby and Bishop Fabbro will be sharing CEW video messages (posted on Board website). As well, Bishop Crosby has pre-recorded a CEW Liturgy of the Word to be shared in our schools. Keri will share the link with Administrators when received from the Diocese of Hamilton. A CEW Twitter campaign "Nurturing Hope – Together We Can" will engage our schools, families, and communities in sharing hope through social media. Details for the campaign will be shared with Administrators well in advance of CEW.
