9. Community Agency Updates

Kim Fraser - Indigenous Child and Youth Team at Child and Family Services of Grand Erie

The amalgamation continues to progress. Currently using a hybrid work model with some staff in person and some working remote. There is a new Children Service Worker making 7 full time CSW's on our team.

Brandi Bertling – Child and Family Services of Grand Erie (CFSGE)

There are several resources and links available on the CFSGE website that everyone is encouraged to look at. The agency is looking for volunteer drivers. If you know someone who may be interested, they can look for someone to connect with on our website. Updating staff identification cards and business cards is underway in hopes of improving familiarity in the community.

Christina Ferrell - Woodview

Woodview underwent a service transformation in September. A letter was sent to all families currently receiving services encouraging them to set up an appointment with a Service Coordinator. These appointments allowed families to express their needs and received referrals to appropriate services. This was a great success with many families reaching out for support.

Kerri Lomax - Principal, Elementary

September has been busy channeling parents' questions and concerns. The Board's support services have been touching base with schools and starting visits to help support students with their return to school.

Mischa Dinsmore - Lansdowne Children's Centre

The Smile Cookie campaign is on from September 19th until the 25th and Lansdowne is splitting the proceeds with Brant Food for Thought. Lansdowne's Heroes Walk and Roll and a family carnival is coming up on October 1st. A reminder to look at our website for numerous resources available for families and service providers. Currently the school support therapists are busy in schools.

Nil Woodcroft - Haldimand-Norfolk REACH

September has been a busy month supporting participants with transition to school. Feedback from agency staff has been gathered and meeting with the Boards to review successes, challenges and gaps, as well as review plans moving into 2023. Currently meeting with the Autism program at REACH to review the first Entry to School program and discuss steps moving forward for those participants enrolled in multiple programs at REACH to ensure a seamless delivery of service for participants, families and school staff.

Lauren Freeborn - Contact Brant

The Urgent Response Program began in May and staff are at capacity. Looking for creative solutions to keep up with demand. Contact Brant no new updates other than the URP. Just started introducing this in May and our workers are at capacity – looking for creative solutions to keep up with demand. New committee member hopefully in October/November to introduce them.

Michelle Drake - Crossing all Bridges

Crossing All Bridges is a non-profit organization for adults ages 21+ who may be on the spectrum, have cerebral palsy, down syndrome, etc. The focus is to offer an opportunity for continued learning through 5 core programs, which include: culinary, digital innovation, sports and recreation, expressive arts, and community and culture.

Crossing All Bridges is fully operational with in-person learning with a hybrid model currently in the works. There is a fundraiser coming up on October 14th called Witches Night Out for women only.

Bill Chopp - Trustee

Trustee Chopp expressed gratitude on behalf of the Board of Trustees to all members of the committee. The input and advocacy that stems from the committee is extremely valuable, especially when determining how to allocate resources. A thank you was also extended to the new Chair and Vice Chair.

10. Reports

10.1 Superintendent of Education

Superintendent Greco shared that the Special Education Department met last year to identify goals for the department as the pandemic comes to an end. There was focus on streamlining and enhancing pathways to support, improving processes, and continuing to build capacity in the system.

There has been discussion around enhancing new Educational Assistant's (EA) experience within the Board. Some ideas to improve this include: an EA mentorship program, creating networks for EA's, and an induction program that will map an onboarding experience.

Over the summer, there were a number of assessments completed using money received through a grant. The Board was able to complete a number of Psychoeducational Assessments reducing the waitlist. The Board also retained a psychologist to do gifted assessments and completed 25 during the summer.

The updated Special Education Plan and Annual Report are available to view on the Board's website, committee members are encouraged to review.

1. Opening Prayer and Land Acknowledgement

Lorrie Temple opened the meeting with the Land Acknowledgement and prayer.

2. Welcome

3. Approval of the Minutes

4. Information and Discussion Items

4.1 Keri to Update on Spiritual Theme and Faith Day

Keri Calvesbert gave an overview of the new Board Spiritual Theme, "Catholic Education: We are Many, We are One" rooted in the Scripture passage "We who are many, are one body in Christ, and individually we are members, one of another." (Romans 12:5) The new theme aligns with the OCSTA 2023 Catholic Education Week theme. The new theme will be the focus of the October 4th (Norfolk) and the 7th (Brant/Haldimand) PD Days. On these days, staff will attend Mass at one of three designated parishes. A commissioning of the New Permanent Employees will take place during each Mass. Staff will create a visual representation of the theme to be displayed in schools and sites for the remainder of the school year. Staff will engage in community building, prayer and reflection activities as selected from the Pastoral Resource Package developed by the Board Pastoral Team. The Pastoral Resource is a living document which will be updated monthly and can be used to support Faith Formation throughout the school year.

4.2 David Wells update and sharing

Keri Calvesbert shared that David Wells produced a series of three interactive video messages to be shared with all staff on the October 4th and 7th PD Days to help staff unpack and gain a deeper understanding of the new Board Spiritual theme. On November 8, 2022, David will be presenting in-person to our Administrators and on November 9th, David will be spending a half-day with our Student Achievement Team, Student Services Support Teams, and the Board Pastoral Team. All staff will be invited to attend a presentation by David Wells on the evening of November 8th (either in-person or online) at the Diocese of Hamilton.

4.3 Pen Pal follow up to request from the spring

Keri Calvesbert explained that in October contact information for five schools in Poland hosting students from Ukraine will be shared with schools inviting them to participate in pen-pal letter writing. Participating schools will be asked to update as exchanges occur.

4.4 Curriculum questions/discussion

Committee members expressed some concerns about faith being taught in schools not translating to seeing families at Mass. Fr. Angervil suggested offering a monthly Sunday Mass for Teachers. Fr. Murrin shared the continuous challenges of bridging home, school, and parish, pointing to importance of educators living their faith to model for students. Fr. Augustine shared these similar views. Lorrie Temple explained one of the reasons behind hosting Faith Day Masses in the parish is to help bring staff back into the parish.

4.5 Secondary Faith Activity Sharing

Tara Williams submitted the following report on activities in our Secondary schools: At Holy Trinity, school-wide opening Mass took place with Fr. Charles on Sept. 26th. In preparation for this Chaplain Ian spoke to all grades at the grade level assemblies to prepare them for the Mass, especially the celebration of the Eucharist. Morning prayer resumed on announcements and beginning this month we will have students and staff taking on morning prayer duties as well. This week we are beginning our SSVP collection. Chap Ian and the admin TEAM have been exploring options to bring back the Grade level retreats. We feel these retreats were extremely important to the building of our faith community among students. Assumption College reported that they were the recipients of the Michael Carty Award from the Catholic Education Foundation of Ontario for their submission, "Migrant Worker: Fratelli Tutti in our Midst." Students from the Social Justice class, student Chaplaincy team and ESL program participated in their first encounter in September.

4.6 Elementary Faith Activity Sharing

Heather Graham reported the following activities took place at St. Joseph's School: The school has been immersed in introducing the new Board Spiritual Theme, "We are Many, We are One." The Pastoral Resource Package has been used for staff meetings and parent council meetings. The Catholic Education Week prayer is being shared over the announcements and in the school newsletter. St. Joseph's, along with other Norfolk County Catholic Elementary schools are participating the Norfolk SSVP Thanksgiving Food Drive to support neighbours in need in the local communities. Heather gladly shared that Priest visits began again in the school and St. Joseph's has resumed going to Mass once per month at St. Mary's Parish, Simcoe.

FAMILY LIFE PROGRAMMING AND GENDER IDENTITY

Public Session

BACKGROUND INFORMATION:

Family Life Programming across the province and in the BHNCDSB is outlined by the Assembly of Catholic Bishops using the program: Fully Alive.

DEVELOPMENTS:

Elementary Family Life Education:

In Grades 1 through 8 in Ontario Catholic schools, the program used for instruction in Family Life Education is *Fully Alive*. *Fully Alive* is a Family Life Education program sponsored and approved by the Assembly of Catholic Bishops of Ontario (ACBO).

Guided by the 2012 Family Life Education Curriculum Policy Document, Family Life Education, as it is represented in *Fully Alive*, is intended to pass on a distinctively Catholic view of human life, sexuality, marriage, and family. Its goal is to complement the efforts of families and to support what parents are doing at home. The entire program from Grades 1 through Grade 8 is designed to encourage children to become the people God wants them to be -- to be fully alive.

To note, the focus of the Fully Alive program is learning about family life through social justice action; life and dignity of the human person, equity; and most importantly, loving one another as God loves us.

Educators are reminded in In-services, PD sessions, and PowerPoints that they are sacredly entrusted with their learners; that their role is meant to encounter students where they are and support their well-being; and that their messages and teaching should ALWAYS be in line with the Catholic church and its teachings. Before an educator teaches the Fully Alive lessons, they are to:

- Know their learners
- Know the Family Life Curriculum (overall and specific expectations)
- Know the Fully Alive Content (Teacher Resource, content of Student Text)

NOTE: Teacher Resource highlights content, lesson, vocabulary, notes to the Teacher and outlines difficult questions and scripted answers and also provides "Cautions".

NOTE: Educators are told to refer students to parents/caregivers to support the students, thus creating and reinforcing that the parents are the first educators of the children.

Students are taught that they are wonderfully made by God and are treasured, sacred, and loved.

Gender Identity in Family Life Education

In our Catholic schools, Strand D: Healthy Living – Human Development and Sexual Health expectations in the 2019 Health and Physical Education curriculum are fulfilled by Theme 3 of the Fully Alive program, approved by the Assembly of Catholic Bishops. In teaching the Fully

Alive program, the most recent Health and Physical Education expectations are taught from a Catholic perspective.

In the Ontario Health and Physical Education Curriculum Policy Document, 2019, the word gender or gender related terms are found 137 times and 56 of those are in the glossary and appendices. The use of these terms is NOT part of curriculum expectations, they are made in the preamble to lessons or other sections directed to the teacher for consideration when planning their lessons/programming.

In the Fully Alive program, in primary, gender and gender identity are taught with the teaching that we are all made male and female, created in the image and likeness of God. There are no formal lessons on gender identity outside of this concept.

In the junior grades, beginning in Grade 5, they discuss physical changes of puberty for girls and boys and the age range for this to happen. The teacher is given caution notes for what students may ask questions about relationships and sexual relationships. The teacher is "cautioned" not to judge, that only God knows what is in our hearts, that God has created us out of love and wants us to live according to His plan (Grade 5 Caution notes, theme 3, page 148).

In grade 6 and 7, focus is on discovery and questioning and identity. Essential for educators is to refer questions to parents and caregivers; to reinforce the message of being created male and female, to be life-giving, loving and follow God's plan for sexuality. The Virtue of Chastity is highlighted. Educators continue to share that students are shaped by home, school, church, and media. Students are again reminded of God's call to be in a committed, loving relationship for sexual relationships to occur. They begin to discuss sexual identity for the first time in Grade 7. Teachers are reminded not to judge, to refer to parents, try and let students know they care, and encourage them to discuss questions at home with families.

Finally, in Grade 8, the curriculum engages the topic on human person, gender identity and expression. Noting that, "everyone, man, and woman, should acknowledge his sexual identity, physical, moral, and spiritual difference and complementarity are oriented toward the goods of marriage and the flourishing of family life. The harmony of the couple and of society depends in part on the way in which the complementarity needs, and mutual support between the sexes are lived out." (Catechism of the Catholic Church, no. 2333). They discuss how we define the human person - made in the image and likeness of God with special dignity as a result. They further share that we all have free will to use our intelligence and ability to enter into relationships of love, ability to co-create through the loving union of man and woman in marriage. They talk about special dignity, sharing differences and respecting differences, and the terms gender identity and gender roles and expression are shared.

Overall, in Family Life students from Grades 1-8, are taught that they are created in the image and likeness of God - male and female. That they possess the ability to love and co-create in a loving, committed relationship that the sacrament of marriage offers and affirms.

RECOMMENDATION:

That the Committee of the Whole refers the Family Life Programming to the Brant Haldimand Norfolk Catholic District School Board for receipt.

BACKGROUND INFORMATION:

Ontario Regulation 357/06 - Honoraria for Board Members sets out the method for calculating the limits on honoraria paid under section 191 of the Education Act. The honoraria, in respect of any year of the term in office, consists of the following components: base amount, enrolment amount, and Chair/Vice Chair amounts, as outlined in Board Policy 100.06 – Trustee Honoraria.

DEVELOPMENTS:

There have been no changes to the base amount for trustee honoraria. For the term of office starting November 15, 2022 to November 14, 2023, the only change to trustee honoraria will be the impact of enrolment changes.

Trustees are now paid bi-weekly by direct deposit based on 1/26 of the established honorarium.

The calculation for the trustee honoraria for the period November 15, 2022 to November 14, 2023, is detailed in the chart below, which does not include the student trustee.
