The purpose of this report is to provide the Board with an update on current initiatives, staffing, programming, and supports within the Special Education Department as of October 2025. This update reflects the department's ongoing commitment to providing equitable, inclusive, and evidence-based support for students with diverse learning needs across all BHNCDSB schools. An update on the staffing overview of Educational Assistants was provided. There have been several additional permanent allocations made to meet emerging identified needs. These flexible staffing adjustments ensure that schools can respond promptly to emerging student needs and maintain a safe and supportive learning environment for all. Additional updates were provided on specialized student support services including the benefit of the services of Bartimaeus. Intervention Programs and Literacy Initiatives that align with the Right to Read report and the Board's focus on literacy improvement for all learners were highlighted. New SERT appointments, professional learning, communication and inclusion resources, speech-language and occupational therapy support, and various other initiatives were discussed. The board highlighted the great work of allocating ample special education supports in the budget process and the student successes that come from it.

# 4. Information and Discussion Items

#### 4.1 2025-2026 Pastoral Plan and Faith Day Review

Keri Calvesbert shared the 2025-2026 Pastoral Plan (Board Spiritual Theme), "Catholic Education: Pilgrims of Hope: On the Path to Holiness," rooted in the Scripture, "As God who called you is holy, be holy yourselves." (1 Peter 1:15-16) was officially launched across the district on Faith Day held October 7, 2025. The Pastoral Resource Document containing liturgical, prayer, and community building supports for this year's theme was provided to Administrators. Managers and Supervisors and will be updated monthly throughout the duration of this school year. Keri reported Faith Day for all staff was a success. The day began with Mass in four parishes locations including St. Pius X, Brantford, St. Mary's, Brantford, St. Patrick's, Caledonia and St. Mary's, Simcoe. The new permanent employee commissioning for staff took place during each of the Masses. A time of fellowship with refreshments was provided in all parish hall locations to honour and appreciate staff. Staff traveled to their schools/sites for lunch and participated in afternoon sessions planned by school and site Administrators, Managers and Supervisors. All staff engaged in viewing the video provided by BHNCDSB featuring Bill Acres, Principal, St. Cecilia School, Port Dover sharing his experience of pilgrimage along the Camino de Santiago. Guided questions for discussion and debrief of the video were provided. In the afternoon, staff engaged in a variety of community building, social justice outreach, prayer and reflection activities and closed the day using the CEW prayer cards provided by BHNCDSB. A Faith Day survey was sent out and results once compiled will be used to assist with the planning of next year's Faith Day.

# 4.2 Religion and Family Life Curriculum Updates

Keri Calvesbert noted the new Family Life Program, *Blessed & Beloved* for Grades 2 and 3 has now been fully implemented in all our Elementary schools. Grades 2 and 3 Educators received support for a soft launch implementation of the new program and are receiving ongoing support to learn to navigate the digital resources. In Secondary, BHNCDSB has purchased the new Religious Education Program, "Growing in Faith, Growing in Christ" for Grade 9. The RFL Consultant is meeting with Religious Education Department Heads in early November to plan the support of Grade 9 Educators with implementing a soft launch of the program throughout the duration of the 2025-2026 school year.

# 4.2 Secondary Feedback on Faith Day/Faith Activities

Andrew Hall shared on behalf of St. John's College as part of the afternoon on Faith Day, staff engaged with the video on Pilgrimage provided by BHNCDSB and signed up to participate in one of the following offsite activities:

**Youth Fusion (20-30 staff)** - Youth Fusion is a peer mentorship program for newcomer youth. Through recreation and leadership activities, newcomer youth learn new skills, connect with peers and improve their self-confidence.

**Pathways to Hope (10 staff)** - Serves those who live with Autism (ASD) or other complex needs and aims to help those who care for these individuals and support them on their journey through life.

Why Not Youth Centre (20-30 staff) - The young people who attend Why Not have a few things in common: almost all of them live in poverty, most only have contact with one or fewer of their parents, and even fewer have a safe, consistent place to live. While the organization is not a shelter, it functions like a community living room so that, no matter how many places their clients sleep, the Youth Centre remains the same.

**Friendship House (20-30 staff)** - Empowers individuals experiencing homelessness and poverty by providing comprehensive support to nurture their physical and emotional wellness. **St. Basil's Church (to view replica of the Holy Door)** – The Holy Door plays a large role in a Jubilee year. Staff were invited to view the holy door replica, learn about its importance in a Jubilee year, and hear Fr. Kevin's pilgrimage story.

Following the offsite activities, SJC staff listened to guest speaker, Eric G. Martin (Mohawk & Chippewa Nations, Bear Clan - Stone Carver). Eric shared his artwork and spoke on the following topics: What is the path to holiness through an Indigenous lens? How does Indigenous artwork help along the path to holiness? How does your own artwork help you on the path to holiness and how do you hope it helps others?

#### 5. Questions/Discussions

**5.1** Receiving the Eucharist: Trustee Dignard shared an observation from the Faith Day Mass about a staff member who was unsure how to receive the Eucharist. Trustee Dignard recommended that staff be reminded at the next available opportunity that it is important to consume the Eucharist immediately after it is received from the priest or eucharistic minister at mass. For future Faith Day Masses, the Pastoral Team will include remarks about how to receive in the opening commentary.

**5.2** Diocese of London Mass Protocols: Superintendent Lawlor shared the Diocese of London as requested by Bishop Fabbro has recently been asked to re-examine the way Mass is celebrated, particularly when it comes to Silence and Posture in the Liturgy:

**Silence in the Liturgy:** The Constitution on the Liturgy says, the Church earnestly desires that all the faithful should be led to fully conscious, and active participation in liturgical celebrations and that silence is a privileged means of promoting the participation of the people of God in the liturgy. Sacred silence is not an empty absence of noise but an active and integral part of the liturgy. The purpose of silence changes depending on when it occurs.

- Before Mass begins to allow us to prepare for the sacred action.
- In the penitential act, when we are invited to recall what separates us from God and remembering our dependence on God's mercy.
- At the Collect (the prayer after the Gloria), when the presider says, "Let us pray", we
  reflect on what we bring to the liturgy, and for whom we wish to offer the Mass; the
  presider then collects all of our prayers into one and offers them to God.
- After the first and second readings, the Gospel, and the homily, silence allows the us to grasp the sense of what was proclaimed in the word and to internalize it so as to better respond to the prompting of the Holy Spirit.
- After the Communion procession is finished, all may sit or kneel to reflect on the gift of the Eucharist and to offer our personal thanksgiving.

**Posture in the Liturgy:** Body language can convey feelings and states of mind, and liturgical postures are a way to express internal responses to God's love and truth. The unified postures and gestures of the congregation express our collective participation in the Body of Christ and help to engage the entire person in prayer and worship.

We recognize the presence of some among us who are not able to stand for any length of time or kneel, depending on age or infirmity, so heroic effort to conform to the directives is not expected. In other words, do what you are able to do.

The normal postures in Catholic liturgy are **standing**, **sitting**, **and kneeling**. Here are the postures we should be observing, some new, some not:

- At the Preparation of the Offerings, the people are sitting but should **stand after the washing of the priest's hands** to be ready for the invitation, *pray brothers and sisters*, and make the response.
- We kneel after the *Holy, holy, holy,* and stand after the *Great Amen*.
- Our practice is to kneel at the end of the Lamb of God. The Priest then genuflects, holds the Host above the paten or chalice, and says Behold the Lamb of God to which the Priest and assembly respond Lord, I am not worthy. At the end of this prayer, the assembly staries,

- after which the Priest will receive Communion, and all remain standing during the
  Communion Procession until everyone has received Communion. Procession starts
  when the priest receives Communion and ends only when the last person has received
  Communion Then, at that point, people may sit or kneel. The Communion Holy
  Communion is to be received standing, though individual members of the faithful may
  choose to receive Communion while kneeling.
- In some places the practice is to continue standing until the Blessed Sacrament is placed in the Tabernacle. This should not continue, because **the focus must be on the Holy Communion received and not on the Blessed Sacrament in the Tabernacle**.
- Following a period of silence, the priest and people stand and, after saying "Let us pray," the priest offers the Prayer After Communion which ends the Communion Rite.

**5.3** Faith Formation for Staff: Superintendent Lawlor mentioned we are working with Communications on creating a site to be housed in the bhnHUB which will offer a collation of Adult Faith Formation opportunities that can be accessed by staff and will be updated on a regular basis.

#### 6. Correspondence

Woodview Mental Health and Autism Services updated that they held their 16<sup>th</sup> anniversary at the Ancaster Fairgrounds, and it was well attended. Also, the upcoming holiday party will be held in December.

# Jennifer Rudyk

Principals updated that in the schools, Grade 4 CogAT testing is underway and Individual Education Plan's (IEP's) went home. There is Catholic School Advisory Council meeting on October 21, 2025, at the Catholic Education Centre.

# 8. Student Achievement Lead and Superintendent of Education

The Special Education Department has had a strong start to the 2025–26 school year, with a number of initiatives and professional learning opportunities underway:

- The department hosted its first Parent Engagement Night on October 1, 2025, with strong
  participation and positive feedback. Seventy-eight percent of attendees were families of
  students in Grade 7 and above, while twenty-two percent were from Grade 4 and under.
  There was representation from all three counties, and thirteen community agencies
  participated in the event.
- Training for new Special Education Resource Teachers (SERTs) has been completed, covering topics such as IEP expectations, structured learning, safety plans, OnSIS and PowerSchool, Hawaii Early Learning Profile (HELP), and Special Equipment Amount (SEA) processes. In addition, Empower Reading training was provided for new SERTs.
- The first Community of Practice meeting took place on September 25, 2025, featuring Dr.
  Jim Little's presentation on Understanding Psychological Assessment, and a presentation
  from Lansdowne Children's Centre on Occupational Therapy, Physiotherapy, and SpeechLanguage Pathologist (S-LP) supports. Other topics included the Individual Placement and
  Review Committee (IPRC) process, IEP guidelines, progress reporting, nursing supports,
  SERT mentorship, CogAT, Applied Behaviour Analysis, and S-LP services.
- Educational Assistant (EA) allocation for the school year has been finalized, with 3.5 additional EAs added across the system to support student needs.
- The department recently completed several system-level IPRCs for the Primary Learning Strategies Class, Assumption College School (ACS), and St. John's College special classes. Additionally, ACS hosted an opening liturgy to welcome new students and staff to the self-contained programs.

# NEW TEACHER INDUCTION PROGRAM (NTIP) UPDATE

**Public Session** 

# **BACKGROUND INFORMATION:**

The New Teacher Induction Program (NTIP) is a Ministry of Education—mandated program designed to provide new teachers with the professional learning, mentorship, and evaluation necessary to support a successful transition into the teaching profession. The NTIP is the second step in a continuum of teacher professional learning following initial teacher education and represents a critical investment in teacher confidence, efficacy, and instructional growth.

The overarching goals of NTIP are to help new teachers develop:

- Confidence 'I can do it; I have the supports to be successful.'
- Efficacy 'My teaching makes a difference in the lives and learning of every student.'
- Instructional Practice 'I can respond to diverse learning needs with effective strategies.'
- Commitment to Continuous Learning 'I want to grow as a professional in collaboration with my students, colleagues, and community.'

These goals are achieved through three induction elements: orientation to the school and board, mentoring by experienced teachers, and professional learning tailored to individual teacher needs. The BHNCDSB NTIP model aligns fully with this provincial framework and integrates relational trust, differentiated learning, and authentic professional collaboration grounded in the Catholic faith.

#### **DEVELOPMENTS:**

#### **Program Structure and Participation**

For the 2025–2026 school year, the BHNCDSB NTIP has been expanded and refined to provide structured, differentiated support to over 100 eligible teachers. Eligibility and level of support were determined collaboratively with Human Resources, in accordance with Ministry criteria.

In total, 109 teachers are participating in NTIP for 2025–2026, supported by 394 release days for mentorship and/or self-directed professional learning. The program ensures compliance with NTIP requirements for permanent hires, who must complete two satisfactory Teacher Performance Appraisals (TPAs) within 24 months.

#### **Onboarding and Orientation**

All new teachers participated in the New Teacher Onboarding Session on August 26, 2025, titled 'Called to Teach, Chosen to Serve.' The session introduced participants to the board's mission, NTIP leadership team, and departmental supports. The day reflected the spiritual theme, 'Pilgrims of Hope,' emphasizing faith, community, and collaboration.

#### **Mentorship Framework**

The mentorship component of NTIP remains central to its success. BHNCDSB has shifted from a single-board mentor model — in which one mentor provided system-wide resources — to a more personalized and relational framework that includes one-to-one mentorship, school-based mentorship, and access to broader mentoring webs. This model ensures that each new teacher receives differentiated, context-specific support while also benefiting from a network of experienced educators across the system. Mentors receive dedicated training, release time, and ongoing guidance to foster relational trust, facilitate learning-focused conversations, and promote reflection through co-planning, classroom observation, and professional dialogue. Mentors are recruited through an annual call for interest and receive dedicated training, release time, and support. Foundational mentoring skills include building relational trust, facilitating

learning-focused conversations, providing meaningful feedback, and utilizing powerful mentoring designs such as co-planning and reflection.

# **Professional Learning and Individual NTIP Strategy**

Professional learning opportunities are embedded throughout the school year and include afterschool sessions, faith formation, and online modules via the Student Achievement Team Hub. The Individual NTIP Strategy (INS) serves as a living document guiding professional goals and reflection.

#### **Faith and Formation**

Faith formation is woven throughout the NTIP experience. The theme 'Pilgrims of Hope' invites mentors and mentees to journey together in faith, cultivating a culture rooted in reflection, compassion, and service.

#### **Next Steps**

The NTIP Leadership Team will continue to monitor program delivery, collect feedback, evaluate mentor-mentee pairings, and review professional learning data to inform future planning.

#### Summary

The 2025–2026 NTIP embodies both the provincial NTIP vision and the board's Catholic mission. With over 100 educators engaged and 394 release days supporting their growth, the program promotes mentorship, professional learning, and faith-based formation. Grounded in the theme 'Pilgrims of Hope,' this year's program fosters collaboration and lifelong learning among BHNCDSB's newest educators.

# Special Education Department Report – Literacy Intervention Program for Complex Learners (Readopia)

**Public Session** 

#### **BACKGROUND INFORMATION:**

The Special Education Department is very pleased to share that a new literacy program, *Readtopia*, has been introduced across the Brant Haldimand Norfolk Catholic District School Board for our most complex learners in Community Living, Personal Active Learning (PAL), and Spectrum Abilities Program (SAP) classrooms.

This initiative directly responds to the recommendations of the Right to Read Report, which emphasized the need for evidence-based, comprehensive literacy instruction accessible to all students — including those with the most significant learning challenges.

For many years, supporting literacy development for our most complex learners has been a significant struggle. *Readtopia* provides a holistic, developmentally appropriate approach that values the dignity and potential of every learner.

Unlike programs that focus only on isolated literacy components, *Readtopia* offers a comprehensive and integrated literacy curriculum that supports:

- Phonics and phonemic awareness
- Vocabulary and background knowledge
- Reading comprehension
- Writing development
- Communication and self-expression

This program allows our students to experience the full cognitive, academic, and social benefits of literacy, advancing the Board's commitment to equity, excellence, and high expectations for all learners.

#### **DEVELOPMENTS:**

#### **Program Features**

Readtopia provides a robust and flexible framework designed to meet diverse literacy needs while maintaining age-appropriate and engaging content. Its key features include:

- Differentiated instructional materials spanning emergent, transitional, and early conventional readers
- Online access for use in any instructional setting
- Age-respectful thematic units integrating phonics, comprehension, writing, and communication
- Cross-curricular connections to Science, Life Skills, Social Studies, and Math

- Experiential learning supports such as video content to build background knowledge and vocabulary
- Assessment tools including Emergent Literacy Measures, Fluency Passages, and Student Placement Tools
- Embedded functional life skills such as daily living, interpersonal communication, and employment readiness
- Over 30 thematic units (and growing), each offering 6–12 weeks of instructional content

Importantly, *Readtopia* is easy to implement and does not require storage of personalized student data in the cloud, maintaining student privacy while ensuring broad accessibility.

# **Professional Learning and Support**

Implementation of *Readtopia* is being supported by Bridges Canada, who provide professional learning, coaching, and ongoing technical assistance. A series of professional development sessions have been organized for all participating educators to ensure a strong, consistent rollout.

Training sessions are facilitated at the Catholic Education Centre (CEC) by:

- Stephanie Bergman, Speech-Language Pathologist
- Tracie Witteveen, System Special Education Consultant
- Sandra De Dominicis, Vice-Principal of Inclusive Learning and Special Education

#### Training Schedule:

- Session 1: October 27 (morning)
- Session 2: November 3 (morning)
- Session 3: December 10 (morning)
- Session 4: January 14 (morning)

This phased approach allows for reflection, practice, and refinement between sessions, ensuring effective implementation and sustained teacher confidence.

# Why This Matters for BHNCDSB

As the Right to Read Report highlighted, literacy is a human right—a gateway to communication, independence, and lifelong learning. For too long, students with complex learning needs have been underserved in the area of literacy.

Readtopia changes this narrative by offering our students meaningful literacy engagement, equitable access to rich, evidence-based instruction, and opportunities to communicate, express, and grow.

This initiative reflects BHNCDSB's steadfast dedication to fostering inclusion, honouring each person's dignity, and believing in the potential of every learner.

#### **Staff Input and Existing Practices**

To better understand current literacy supports, a minds-up activity was conducted with participating staff. Teachers and department members anonymously listed the strategies and resources they currently use to promote literacy development. Their responses included:

- Brigance
- iXL Diagnostics
- Learning Upgrade
- Raz-Kids
- Prodigy
- Epic
- Lexia
- Structured Learning
- Leveled Readers
- AAC Devices
- Read Alouds

This input illustrates both the dedication and creativity of our educators in supporting literacy development across a range of needs. However, it also highlights a critical need for greater consistency and coherence in how literacy instruction is delivered to our most complex learners.

While individual teachers employ strong, research-informed practices, the absence of a unified framework can result in uneven opportunities for students. *Readtopia* addresses this need by providing a consistent, evidence-based, and developmentally appropriate program that ensures all students—regardless of classroom placement or teacher—receive equitable access to high-quality literacy instruction.

#### Summary

The introduction of *Readtopia* marks a significant milestone for the BHNCDSB's Special Education Department. It reflects our collective belief that all students can learn to read and write when provided with the right tools, instruction, and support.

Readtopia embodies the Board's spiritual and educational mission by empowering students to find their voice, experience success, and engage fully in learning—truly living out our shared call to be 'Pilgrims of Hope.'
