#### 6. Presentations

## Fetal Alcohol Spectrum Disorder - Linda McFadden and Lyndsey Campbell

Linda McFadden shared that FASD is a lifelong disability that affects the body and brain of those exposed to alcohol while in the womb. Those affected need assistance throughout their lives. 1 in 25 people in the population have it. Consuming alcohol through all trimesters of pregnancy can cause this.

Linda shared facts and symptoms of FASD. A slide show will be included with the minutes. The presentation outlined the adverse outcomes of the impairments, and the need to address the behaviour. Mental health issues are common.

Lyndsey Campbell highlighted the idea "think can't, not won't" and "brain damage, not bad." Lyndsey shared the "eight magic keys" and discussed methods to assist FASD students. Support services are key for families. Developing goals help to keep things stable. FASD is under diagnosed and there is a stigma to the disorder.

## Lexia Core5 Presentation – Susan Fitzgerald

Susan Fitzgerald presented an overview of the Special Education Lexia Pilot Project, now in year three of its implementation across Brant Haldimand Norfolk Catholic District SB. The following areas were presented, starting with a brief explanation of the steps taken in researching Lexia's efficacy as a literacy intervention program before its implementation across our system.

- Criteria for assigning a Lexia license to a student
- License request process required by school teams when they are requesting Lexia licenses
- District license update total number of current licenses in our District Special Education
- Training professional development training in Lexia provided to SERTs, principals, system special education staff, and senior administrators
- Program Overview a brief explanation of Lexia's Blended Learning Model and the student experience on Lexia
- Tracking Student Progress the gains students have made in their reading and literacy skills as demonstrated by completion of Lexia units and levels
- Student Success Stories student, parent, teacher, and SERT testimonials about improved reading skills, increased self-confidence, greater level of independence and motivation to learn

## Lauren Freeborn – Service Planning Coordinator, Contact Brant

Staff continue to work virtually to support client needs but have the flexibility to provide services in person through porch/outside visits if needed. Contact Brant will be coordinating a meeting on June 25<sup>th</sup> 2021 to get local input into the new OAP (Ontario Autism Program) Urgent Response proposal. The definition of Urgent Response is time-limited services and supports that are intended to respond rapidly to a specific need and prevent further escalation of risk of harm to self, others and property.

## Nil Woodcroft - Haldimand-Norfolk REACH

HN REACH is currently in Step 1 which includes: at 25% capacity at Townsend site, in person visits continuing on individual basis, Family Early Intervention Program continues to provide supports to children with special needs in licensed childcare settings, Bramble Retreat remains closed.

Regarding Developmental Services- The Ministry has allowed recipients of Special Services at Home to continue to utilize their funds to purchase items from an expanded eligible expense list. We continue to support families with these purchases.

Autism and Behavioural Services will be offering new programs in late summer and fall to include: 1. Social ABC's program through the Ontario Autism Program and 2. Pivotal Response Training program through the Ontario Autism Program. Summer camp will also be offered which will include both in-person and virtual for the months of July and August. Autism and Behavioural Services is currently working on a proposal for Entry to School program set to begin March 2022.
