# 6. Presentation

6.1 Phonemic Awareness & Bridge the Gap Awareness

The Board's Speech and Language Pathologists Stephanie Bergman and Meagan Courneyea shared a presentation highlighting the importance of Phonemic Awareness and Bridge the Gap Awareness.

6.2 Transportation & Stability Support Funds

An overview of the Transportation and Stability Support Funds was given by Shannon Korber. This program was created by the Ministry of Education to assist families in service to help with transitions

such as school transfers. The program is used in collaboration with Children's Aid Society, schools, and transportation services. Other stability supports may include technology, assessments, or helping a child attend an event.
